

NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR HIRING OF TRANSPORTATION SERVICES FOR A PERIOD OF 2 YEARS AT PETRONET LNG LIMITED, KOCHI (KERALA) INDIA

Petronet LNG Limited, a company promoted by Bharat Petroleum Corporation Limited **("BPCL")**, GAIL (India) Limited **("GAIL")**, Indian Oil Corporation Limited **("IOC")** and Oil & Natural Gas Corporation Limited **("ONGC")**, is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for "Hiring of Transportation Services for a Period of Two Years" at PLL's Kochi LNG Terminal at Kochi (India). Bids to be submitted in accordance with the Tender Document reference no: **PLL/KOCHI/ADM/SER/3718-R1/2018-19**

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

BID EVALUATION CRITERIA (BEC):

Commercial:

- **1.** The bidder should submit Earnest Money Deposit (EMD) for an amount of Rs. 3,60,000.00 (Rupees Three Lakhs and Sixty Thousand Only) as per Clause-15 of Annexure-IV.
- 2. The average annual turnover of the Bidder in similar works shall be minimum Rs. 1,50,00,000.00 (Rupees One Crore and Fifty Lakhs Only) during the financial years 2014-15, 2015-16 and 2016-17. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial years (2014-15, 2015-16 & 2016-17) duly certified by statutory auditor of the company.
- **3.** Net worth of the Bidder should be positive during preceding financial year i.e. for FY 2016-17.
- **4.** The Bidder should have following experience during last five years, the last 5 (five) years shall be counted from the last day of bid submission date:
- (a) One similar contract of value not less than Rs. 150.00 Lakhs or
- (b) Two similar contracts of value not less than Rs. 80.00 Lakhs each or
- (c) Three similar contracts of value not less than Rs. 60.00 Lakhs each.

Technical:

- **1.** Bidder should own at least a fleet of 10 (ten) commercial vehicles (cars) out of which 5 (five) should be in the name of the bidder / Proprietor (documentary evidence in the form of RC Book, Insurance Policy etc. to be submitted).
- **2.** Bidder should have an office in Kerala state (documentary evidence to be submitted).
