

NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR CONSTRUCTION OF RCC DRAINAGE SYSTEM AND RELATED WORKS AT PETRONET LNG LIMITED, KOCHI (KERALA) INDIA

Petronet LNG Limited, a company promoted by Bharat Petroleum Corporation Limited **("BPCL")**, GAIL (India) Limited **("GAIL")**, Indian Oil Corporation Limited **("IOC")** and Oil & Natural Gas Corporation Limited **("ONGC")**, is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for "CONSTRUCTION OF RCC DRAINAGE SYSTEM AND RELATED WORKS" at PLL's Kochi LNG Terminal at Kochi (India). Bids to be submitted in accordance with the Tender Document reference no: **PLL/KOCHI/CIV/SER/3988/2018-19**

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

BID EVALUATION CRITERIA (BEC):

Commercial:

- 1. The bidder should submit Earnest Money Deposit (EMD) for an amount of Rs. 4,17,000.00 (Rupees Four Lakh and Seventeen Thousand Only) as per Clause-15 of Annexure-IV.
- **2.** The average annual turnover of the Bidder in similar works shall be minimum Rs. 1,60,00,000.00 (Rupees One Crore Sixty Lakhs Only) during the financial years 2014-15, 2015-16 and 2016-17. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial year duly certified by statutory auditor of the company.
- **3.** Net worth of the Bidder should be positive during preceding financial year i.e. for FY 2016-17.
- **4.** The tenderer has not been debarred and / or blacklisted by any Central Government / or any State Government Department(s) and the tenderer should not have any litigation in any of the labour court(s). An affidavit to that effect on Non-Judicial Stamp paper of Rs. 100/- duly notarized shall be enclosed with the technical bid. The proforma of the affidavit is attached with the tender as Appendix-D.

Technical:

- **1.** Experience of having successfully completed similar works during the last 7 years as on 31st March 18 for Oil & Gas sector, Government Departments, Government Undertakings, reputed private sectors etc. should be any one of the following:
- a. Three similar completed works costing not less than the amount equal to Rs.84.0 Lakhs each.

b. Two similar completed works costing not less than the amount equal to Rs.105 .0 Lakhs each.

OR

c. One similar completed work costing not less than the amount equal to *Rs.167.0* Lakhs.

- 2. Vender should have a valid labour license for minimum 50 manpower with effect from 2017 at least.
- **3.** Bidding in joint venture with consortiums not allowed.
