

NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR CARRYING OUT HORTICULTURE MAINTENANCE WORK ON 'AS AND WHEN' REQUIRED BASIS FOR A PERIOD OF TWO YEARS AT PETRONET LNG LIMITED, KOCHI (KERALA) INDIA

Petronet LNG Limited, a company promoted by Bharat Petroleum Corporation Limited ("BPCL"), GAIL (India) Limited ("GAIL"), Indian Oil Corporation Limited ("IOC") and Oil & Natural Gas Corporation Limited ("ONGC"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for "CARRYING OUT HORTICULTURE MAINTENANCE WORK ON 'AS AND WHEN' REQUIRED BASIS FOR A PERIOD OF TWO YEARS" at PLL's Kochi LNG Terminal at Kochi (India). The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

BID EVALUATION CRITERIA (BEC):

Commercial:

- **1.** The bidder should submit Earnest Money Deposit (EMD) for an amount of Rs. 2,76,000.00 (Rupees Two Lakhs and Seventy Six Thousand Only) as per Clause-15 of Annexure-IV.
- **2.** The average annual turnover of the Bidder in similar works shall be minimum Rs. 1,10,00,000.00 (Rupees One Crore and Ten Lakhs Only) during the financial years 2014-15, 2015-16 and 2016-17. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial years duly certified by statutory auditor of the company.
- **3.** Net worth of the Bidder should be positive during preceding financial year i.e. for FY 2016-17.
- **4.** The tenderer has not been debarred and / or blacklisted by any Central Government / or any State Government Department(s) and the tenderer should not have any litigation in any of the labour court(s). An affidavit to that effect on Non-Judicial Stamp paper of Rs. 100.00 (or higher) duly notarized shall be enclosed with the technical bid. The proforma of the affidavit is attached with the tender as Appendix-D.

Technical:

- **1.** The Bidder should have following experience during last five years, the last 5 (five) years shall be counted from the last day of bid submission date.
- (a) One (01) similar contract of value not less than Rs. 110.00 Lakhs Or
- (b) Two (02) similar contracts of value not less than Rs. 60.00 Lakhs each Or
- (c) Three (03) similar contracts of value not less than Rs. 40.00 Lakhs each.

 The Bidder shall submit work/service order copy(ies)/completion certificate(s) in support of the above.
