

# NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR MEDICAL SERVICES AT OCCUPATIONAL HEALTH CENTRE (OHC) AT PETRONET LNG LIMITED, DAHEJ

### **Commercial**

- 2. The Bidder should have following experience in similar work during last five years; the last 5 (five) years shall be counted from the last day of bid submission date.
  - a) One (01) similar contract of value not less than INR 50 lakh or,
  - b) Two (02) similar contracts of value not less than INR 30 lakh each or,
  - c) Three (03) similar contracts of value not less than INR 22 lakh each.

The Bidder shall submit work /service order copy (ies) and their completion certificate(s) in support of the above.

#### **Technical**

1. The Managing Doctor/Agency should have minimum 02 years of experience in managing various occupational health centre functions, Medical emergencies, OPD cases, Coordination functions, Health surveillance, Health Awareness, Medical examination of employees, Maintenance of all OHC equipment/Gadgets, Statutory/Audit Requirements, First Aid Training etc.

The Bidder shall submit documents in support of the above technical requirements.
