

## NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR COATING OF CONCRETE STRUCTURES AT PETRONET LNG LIMITED, DAHEJ

**Petronet LNG Limited (PLL)**, a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

## **Commercial**

- 1. The Bidder shall submit Earnest Money Deposit (EMD) for an amount of INR 2,00,000/- (Indian Rupees Two Lakh only) in the form of Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd. The Bank Guarantee should be from a scheduled / Nationalized bank.
- The average annual turnover of the Bidder in similar works shall be minimum INR 125,00,000/- (Indian Rupees One Crore and Twenty Five Lakh only) during the financial year 2015-16, 2016-17 and 2017-18. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial years duly certified by statutory auditor of the company.
- 3. Net worth of the Bidder should be positive during preceding financial year.
- 4. The Bidder should have following similar experience during last five years, the last 5 (five) years shall be counted from the last day of bid submission date.
  - a) One (01) similar contract of value not less than INR 75 lakh or,
  - b) Two (02) similar contracts of value not less than INR 40 lakh each or,
  - c) Three (03) similar contracts of value not less than INR 27 lakh each.
