



**NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR  
PAINTING WORK OF GAS TURBINE GENERATORS (PHASE-I)  
AT PETRONET LNG LIMITED, DAHEJ**

**Petronet LNG Limited (PLL)**, a company promoted by Bharat Petroleum Corporation Limited (“**BPCL**”), GAIL (India) Limited (“**GAIL**”), Indian Oil Corporation Limited (“**IOC**”) and Oil & Natural Gas Corporation Limited (“**ONGC**”), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for “**Painting Work of Gas Turbine Generators (Phase-I)**” at PLL’s Dahej LNG Terminal at Gujarat (India). Bids to be submitted in accordance with the Tender Document reference no. PLL/DHJ/RC/7700/2019.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

**Bid Evaluation Criteria (BEC)**

**Commercial**

1. The Bidder shall submit Earnest Money Deposit (EMD) for an amount of INR 135,000/- (Indian Rupees One Lakh & Thirty Five Thousand only) in the form of Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd. The Bank Guarantee should be from a scheduled / Nationalized bank.

Firms registered with NSIC will be exempted from payment of Earnest money/Bid Bond provided they are registered upto the monetary limits and for the items they intend to quote against PLL tender.

2. The average annual turnover of the Bidder in similar works shall be minimum INR 60,00,000/- (Indian Rupees Sixty Lakh only) during the Financial year 2015-16, 2016-17 and 2017-18. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial years duly certified by statutory auditor of the company.
3. Net worth of the Bidder should be positive during preceding financial year.
4. The Bidder should have following experience during last five years; the last 5 (five) years shall be counted from the last day of bid submission date.
  - a) One (01) similar contract of value not less than INR 51 lakh or,
  - b) Two (02) similar contracts of value not less than INR 27 lakh each or,
  - c) Three (03) similar contracts of value not less than INR 20 lakh each.

The Bidder shall submit work /service order copy (ies) and / or, their completion certificate(s) in the support of the above.

**Technical**

Work experience of Having executed at least 3 similar jobs in Hydrocarbon sector (Refineries / Petrochemicals / Gas Processing - Onshore / Fertilizers / Oil or Gas terminals / Offshore) in the last 05 (five) years reckoned from bid submission date. Similar jobs means, the applicator should have successfully executed an area of minimum 1500 sq. mtr using High temperature paint with dry blasting at Flare stack of Chimney at a height of 40 mtr or more using scaffolding.

Bidders to provide reference list of at least 2 different clients. The Bidder shall submit work /service order copy (ies) and / or, their completion certificate(s) in support of the above.
