

NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR INSTALLATION AND COMMISSIONING OF TWO FIRE WATER PUMP SETS AND THE ASSOCIATED WORKS AT PETRONET LNG LIMITED, KOCHI (KERALA) INDIA.

**Petronet LNG Limited**, a company promoted by Bharat Petroleum Corporation Limited ("BPCL"), GAIL (India) Limited ("GAIL"), Indian Oil Corporation Limited ("IOC") and Oil & Natural Gas Corporation Limited ("ONGC"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for Installation and commissioning of two fire water pump sets and the associated works at PLL's Kochi LNG Terminal at Kochi (India). Bids to be submitted in accordance with the Tender Document reference no: PLL/KOCHI/MECH/PUR/3869-A/2019-20

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

# **BID EVALUATION CRITERIA (BEC):**

### Commercial:

- **1.** The bidder should submit Earnest Money Deposit (EMD) for an amount of Rs. 3,10,000.00 (Rupees Three Lakhs Ten Thousand Only) as per Clause-15 of Annexure-IV.
- **2.** The average annual turnover of the Bidder in similar works shall be minimum Rs. 1,17,00,000.00 (Rupees One Crore Seventeen Lakhs Only) during the financial years 2015-16, 2016-17 and 2017-18. The Bidder shall submit balance sheet, profit and loss acco5unt and Income Tax Return copies for last three financial year duly certified by statutory auditor of the company.
- **3.** Net worth of the Bidder should be positive during preceding financial year i.e. for FY 2017-18.
- **4.** The tenderer has not been debarred and / or blacklisted by any Central Government / or any State Government Department(s) and the tenderer should not have any litigation in any of the labour court(s). An affidavit to that effect on Non-Judicial Stamp paper of Rs. 100.00 duly notarized shall be enclosed with the technical bid.

# Technical:

1. Experience of having successfully completed similar works during the last 7 years as on 31st March 18 for Oil & Gas sector, Government Departments, Government Undertakings, reputed private sectors etc. should be any one of the following:

a. Two similar completed works costing not less than the amount equal to Rs. 60.00 Lakhs each.

OR

b. One similar completed work costing not less than the amount equal to Rs. 117.00 Lakhs.

**2.** The tenderer / contractor must visit the premises viz. Petronet LNG Limited-Puthuvypu SEZ-Kochi and ascertain the type and nature of work to be done.

Non-submission of the requisite certificates/documents shall render the bid non-responsive and shall be liable for rejection.
