

NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR CRYOGENIC INSULATION OF VESSELS AT PETRONET LNG LIMITED, DAHEJ (GUJARAT) INDIA

Petronet LNG Limited (PLL), a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for "**Cryogenic Insulation of Vessels**" at Petronet LNG Limited, Dahej Terminal. Bids to be submitted in accordance with the Tender Document reference No: PLL/DHJ/RC/7917/2019

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be reected.

Bid Evaluation Criteria (BEC)

Commercial

1. The bidder shall submit Earnest Money Deposit (EMD) for an amount of INR 5,45,000/- (Rupees Five Lakhs and Forty Five Thousand Only) in the form of Online Transfer/Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd., Dahej. Bank Guarantee should be from a scheduled / nationalized bank.

Firms registered with NSIC will be exempted from payment of Earnest Money/Bid Bond provided they are registered upto monetary limits and for the items they intend to quote against PLL tender.

- 2. The average annual turnover of the Bidder in similar works shall be minimum INR 1,22,00,000/-(Rupees One Crore and Twenty Two Lakhs Only) during the financial years 2016-17, 2017-18 and 2018-19. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial years duly certified by statutory auditor of the company.
- 3. Net worth of the bidder should be positive during preceding financial year.
- 4. The bidder should have following similar work experience (*) during last five years. The last 5 (five) years shall be counted from the last day of bid submission date:
 - a) One similar contract of value not less than ₹ 210.00 Lakhs or,
 - b) Two similar contracts of value not less than ₹ 110.00 Lakhs each or,
 - c) Three similar contracts of value not less than ₹ 75.00 Lakhs each.

The Bidder shall submit LOA/Work /service order copy (ies) and their completion certificate(s) in the support of the above.

(*) Similar Work Experience means supply and installation of cold insulation (Service Temperature: -165 deg. C) using PIR/ Foam Glass/ combination of PIR/ Foam Glass as insulation material for piping, equipment, vessels, exchangers, equipment, etc. in a reputed Petrochemical Complex / Petroleum Refinery / Chemical plant / Fertilizer Plant / Gas Processing Complex / LPG Plant / Power Plant in preceding 5 years as on last day of bid submission date.
