

NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR PROVIDING SECURITY SERVICES FOR A PERIOD OF TWO YEARS AT PETRONET LNG LIMITED, DAHEJ (GUJARAT) INDIA

Petronet LNG Limited (PLL), a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for "PROVIDING SECURITY SERVICES FOR A PERIOD OF TWO YEARS" at Petronet LNG Limited, Dahej Terminal. Bids to be submitted in accordance with the Tender Document reference no: PLL/DHJ/SC/8319/2020-21.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

Bid Evaluation Criteria (BEC)

A. Commercial

- 1. The bidder shall submit Earnest Money Deposit (EMD) for an amount of INR 21,06,000/-(Rupees Twenty One Lakh Six Thousand Only) in the form of Demand Draft or Bank Guarantee. The Bank Guarantee should be from any schedule Indian Bank or any branch of international bank situated in India and registered with RBI as schedule foreign bank. The bidder can also submit the EMD through online banking transaction i.e. IMPS/NEFT/RTGS etc. For this purpose, the details of PLL's Bank Account i.e. Account Holder's Name, Account Number, IFSC Code & other details are provided in the tender document.
- 2. The annual turnover of the Bidder in similar works shall be minimum INR 401,50,000 (Rupees Four Crore One Lakh Fifty Thousand only) during any one of the preceding three audited financial years (i.e. 2016-17, 2017-18 and 2018-19). The Bidder shall submit Income tax return copies (Balance Sheet and P&L statement) supporting turnover requirement.
- 3. Net worth of the bidder should be positive during preceding financial year.
- **4.** The working capital of the bidder shall be 10% of the annualized estimated value. In absence of this, bidder shall submit a line of credit from the bank.

B. Technical

- 1. The bidder should have performed one similar work (*) of value not less than INR 401,50,000 (Rupees Four Crore One Lakh Fifty Thousand only) in previous 7 years period. The bidder shall submit Work order copies & their completion certificate in support of above.
- 2. The Bidder should be registered under the Private Security Agencies Regulation Act -2005, of Govt. of Gujarat or concerned act of the governing state and rules made thereunder and amendments thereto.



- 3. The Bidder should have employed more than one thousand (1000) security personnel and should have deployed at least five hundred (500) Ex-servicemen from either Army or Navy or Air Force or para military forces during the year 2018-19+. The Bidder should furnish copy (ies) of work orders in support of the same.
 - (*) Similar Work means-

The Bidder should have experience in providing Security Services in Hydrocarbon Sector/Oil & Gas Sector/refineries/PSUs/private organisation.
