

NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR REPLACEMENT OF GI ROOF SHEET AT PETRONET LNG LIMITED, DAHEJ (GUJARAT) INDIA

Petronet LNG Limited (PLL), a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for "**Replacement of GI Roof Sheet**" at Petronet LNG Limited, Dahej Terminal. Bids to be submitted in accordance with the Tender Document reference no: PLL/DHJ/PR/8436/2020-21.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

Bid Evaluation Criteria (BEC)

A. Commercial

- 1. The bidder shall submit Earnest Money Deposit (EMD) for an amount of ₹ 1,11,700.00 (Indian Rupees One Lakh Eleven Thousand and Seven Hundred Only) in the form of Online Transfer/Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd., Dahej. Bank Guarantee should be from a scheduled/nationalized bank.
- 2. The annual turnover of the Bidder shall be minimum ₹ 38,00,000.00 (Rupees Thirty Eight Lakhs Only) in any one of the 3 (three) preceding audited financial years i.e. FY- 2016-17, 2017-18 and 2018-19. The Bidder shall submit balance sheet and profit and loss account duly certified/attested by notary public with legible stamp in support of this.
- 3. Net worth of the bidder should be positive during the audited Financial Year 2018-19.
- 4. Working Capital of the bidder should be minimum ₹ 7,40,00.00 (Indian Rupees Seven Lakhs and Forty Thousand Only) during the Financial Year 2018-19, in the absence of which a line of credit from Bank shall be submitted.

B. Technical

1. The bidder should have experience of at least one similar work(*) of value not less than ₹ 30,00,000.00 (Indian Rupees Thirty Lakhs Only) in previous 7 (seven) years. The previous 7 (seven) years shall be counted from the last day of bid submission date.

Definition of similar work (*)

Bidder must have successfully completed order of "Installation/Replacement of Roof Sheet/Construction of shed or building with minimum 3000 Sq. Mtr. of roof sheeting work" in any Department under Central or State Govt. of India / Indian PSU / Government Organization / Private Entity / Public Limited Company.



The Bidder shall submit LOA/ Work / Service order copy (ies) and their completion certificate(s) in the support of the above duly certified/ attested by Chartered Engineer and notary public with legible stamp.

If the prospective bidder is executing rate / maintenance / service contract which is still running and the contract value / quantity executed prior to due date of bid submission is equal to or more than the minimum prescribed value in the BEC such experience will also be taken in to consideration provided that the bidder has submitted satisfactory work / supply / service execution certificate issued by the end user.

Note:

A job executed by a Bidder for its own plant/projects cannot be considered as experience for the purpose of meeting requirement of BEC of the tender. However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice(s) duly certified by statutory Auditor of the Bidder towards payments of statutory tax in support of the job executed for Subsidiary/ fellow subsidiary / Holding company. Such Bidders to submit these documents in addition to the documents specified in the bidding documents to meet BEC.
