

NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR PAINTING OF STEEL STRUCTURE & PIPINGS OF LNG TANKS AT PETRONET LNG LIMITED, DAHEJ (GUJARAT) INDIA

Petronet LNG Limited (PLL), a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for "**Painting of steel structure & pipings of LNG Tanks**" at Petronet LNG Limited, Dahej Terminal. Bids to be submitted in accordance with the Tender Document reference no: **PLL/DHJ/RC/8627/2020-21**.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

Bid Evaluation Criteria (BEC)

A. <u>Commercial</u>

- 1. The bidder shall submit Earnest Money Deposit (EMD) for an amount of ₹ 2,67,100.00 (Indian Rupees Two Lakh Sixty Seven Thousand and One Hundred Only) in the form of Online Transfer/Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd., Dahej. Bank Guarantee should be from a scheduled/nationalized bank.
- 2. The annual turnover of the bidder shall be minimum ₹ 90,00,000.00 (Indian Rupees Ninety Lakh Only) in any one of the 3 (three) preceding audited financial years i.e. FY-2017-18, 2018-19 and 2019-20. The Bidder shall submit balance sheet and profit and loss account duly certified/attested by notary public with legible stamp in support of this.
- **3.** Net worth of the bidder should be positive during the audited Financial Year 2019-20
- 4. Working Capital of the bidder should be minimum ₹ 18,00,000.00 (Indian Rupees Eighteen Lakh Only) during the Financial Year 2019-20, in the absence of which a line of credit from Bank shall be submitted.

Note:-

In case, the bidder is not able to submit the data for FY 2019-20; then bidder may submit data of FY 2016-17 for point (2) above and data of FY 2018-19 for point (3) and (4) above.

B. <u>Technical</u>

1. The bidder should have experience of at least one similar work (*) of value not less than ₹ 90,00,000.00 (Indian Rupees Ninety Lakh Only) in previous 7 (seven) years. The previous 7 (seven) years shall be counted from the last day of bid submission date.

Definition of similar work (*)

Bidder must have successfully completed order of "Painting on Terminal Steel Structure & Piping/ Vertical Steel Structures and Steel Vessels" in any Department under Central or State Govt. of India / Indian PSU / Government Organization / Private Entity / Public Limited Company.



The Bidder shall submit LOA/ Work / Service order copy (ies) and their completion certificate(s) in the support of the above duly certified/attested by Chartered Engineer and Notary public with legible stamp.

Note:-

A job executed by a Bidder for its own plant/projects cannot be considered as experience for the purpose of meeting requirement of BEC of the tender. However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice(s) duly certified by Statutory Auditor of the Bidder towards payments of statutory tax in support of the job executed for Subsidiary/ fellow subsidiary / Holding company. Such Bidders to submit these documents in addition to the documents specified in the bidding documents to meet BEC.
