

NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR CARRYING OUT HYDRO TEST OF PRESSURE VESSELS

AT PETRONET LNG LIMITED, DAHEJ (GUJARAT) INDIA

Petronet LNG Limited (PLL), a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for "Carrying out Hydro Test of Pressure Vessels" at Petronet LNG Limited, Dahej Terminal. Bids to be submitted in accordance with the Tender Document reference no: PLL/DHJ/RC/8738/2020-21.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

Bid Evaluation Criteria (BEC)

A. Commercial

1. The bidder shall submit Earnest Money Deposit (EMD) for an amount of ₹ 18,700.00 (Indian Rupees Eighteen Thousand and Seven Hundred Only) in the form of Online Transfer/Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd., Dahej. Bank Guarantee should be from a scheduled/nationalized bank

B. Technical

1. The bidder should have experience of at least one similar work (*) of value not less than ₹ 6,00,000.00 (Indian Rupees Six Lakh Only) in previous 7 (seven) years. The previous 7 (seven) years shall be counted from the last day of bid submission date.

Definition of similar work (*)

Bidder must have successfully completed order of "Ultrasonic thickness inspection, Hydro-test & Certification of Pressure Vessels" in any Oil & Gas Refineries / Petrochemical Plant / Hydrocarbon/ Gas Processing Plant/ Fertilizer Plant/ Power Plant.

The Bidder shall submit Copy of relevant detailed 'LOA/Work/Service Order' including scope of work and schedule of rates (SOR) etc. and its "Completion Certificate" issued by end user/owner. "Completion Certificate" must contain the reference of order no., duration of contract, completed value of job and actual date of completion of work etc. in the support of the above

Note:

A job executed by a Bidder for its own plant/projects cannot be considered as experience for the purpose of meeting requirement of BEC of the tender. However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice(s) duly certified by statutory Auditor of the Bidder towards payments of statutory tax in support of the job executed for Subsidiary/ fellow subsidiary / Holding company. Such Bidders to submit these documents in addition to the documents specified in the bidding documents to meet BEC.
