

# NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR BUS TRANSPORTATION SERVICE AT PETRONET LNG LIMITED, DAHEJ (GUJARAT) INDIA

**Petronet LNG Limited (PLL)**, a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for "Bus Transportation Service" at Petronet LNG Limited, Dahej Terminal. Bids to be submitted in accordance with the Tender Document reference no: PLL/DHJ/SC/8720/2021-22.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

# **Bid Evaluation Criteria (BEC)**

## A. Financial

- 1. The annual turnover of the Bidder shall be minimum ₹ 1,70,00,000.00 (Indian Rupees One Crore and Seventy Lakh Only) in any one of the 3 (three) preceding audited financial years i.e. FY-2017-18, 2018-19 and 2019-20. The Bidder shall submit balance sheet and profit and loss account duly certified/attested by notary public with legible stamp in support of this.
- 2. Net worth of the bidder should be positive during the audited Financial Year 2019-20.
- 3. Working Capital of the bidder should be minimum ₹ 34,00,000.00 (Indian Rupees Thirty Four Lakh Only) during the Financial Year 2019-20, in the absence of which a line of credit from Bank shall be submitted.

# B. Technical

1. The bidder should have experience of at least one similar work (\*) of value not less than ₹ 1,70,00,000.00 (Indian Rupees One Crore and Seventy Lakh Only) in previous 7 (seven) years. The previous 7 (seven) years shall be counted from the last day of bid submission date. The Bidder shall submit LOA/ Work Order / Agreement/ Service Order copy(ies) (including extensions, if any) and their completion certificate(s) in support of above.

# (\*) Definition of "Similar Work"

"providing bus and it's operation and maintenance services for at least 2 (two) years of operation"

If the prospective bidder is executing rate / maintenance / service contract which is still running and the contract value / quantity executed prior to due date of bid submission is equal to or more than the minimum prescribed value in the BEC such experience will also be taken in to consideration provided that the bidder has submitted satisfactory work / supply / service execution certificate issued by the end user.



#### Note:

- 1. The documents in support of the technical criteria shall be duly certified/ attested by Chartered Engineer and Notary public with legible stamp.
- 2. A job executed by a Bidder for its own plant/projects cannot be considered as experience for the purpose of meeting requirement of BEC of the tender. However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice(s) duly certified by statutory Auditor of the Bidder towards payments of statutory tax in support of the job executed for Subsidiary/ fellow subsidiary / Holding company. Such Bidders to submit these documents in addition to the documents specified in the bidding documents to meet BEC.
