

# <u>Tender for Architectural Consultancy, Design & Engineering, Project & Construction Management</u> <u>Services For Development Of Affordable Rental Housing Complexes (ARHC) At Eksal Village, Dist-</u> <u>Bharuch, Gujarat</u>

**Petronet LNG Limited**, a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids under single stage two-bid system from prospective bidders to submit their qualification proposals in accordance with tender document (**PLLDELPR000302021**), for Architectural Consultancy, Design & Engineering, Project & Construction Management Services For Development Of Affordable Rental Housing Complexes (ARHC) At Eksal Village, Dist- Bharuch, Gujarat.

The Bidder should meet the following Techno Commercial Criteria and any Bidder not meeting the same will be rejected.

# 1. Technical & Financial Evaluation Criteria

### a. Technical Criteria

- i. Bidder should have successfully completed ARCHITECTURAL CONCEPT DESIGN, PLANNING, ENGINEERING, CONSTRUCTION SUPERVISION, PROJECT MANAGEMENT of at least one similar work having minimum building(s) built-up area of 15000 square metres along with associated infrastructure facilities, during last 5 years ending on previous day of last date of submission of bids.
- ii. The Registered Office or one of the Branch Offices of the Bidder must be located in Gujarat. Details regarding bidder's office establishment must also be provided.
- iii. The Bidder should have valid registration with council of Architecture constituted by Govt. of India Under the provision of the Architects Act, 1972.

### b. Financial criteria

- i. Annual Turnover: Bidder's minimum Annual Turnover shall be Indian Rupees One Crore only (INR 1 Crore) in any of the preceding three financial years prior to the prescribed Bid Submission date i.e. 2018-2019, 2019-2020, 2020-2021.
- ii. Net worth of the Bidder as on 31<sup>st</sup> March of previous Financial Year i.e FY 2020-21 should be positive.
- iii. Working Capital: Working Capital of the Bidder must be minimum of INR 19 Lakh as on 31st March of previous Financial Year i.e. FY 2020-21.

# Note: The Bidders who are meeting the above Technical & Financial criteria shall only be qualified for further evaluation.

# **Documents in support of Technical Criteria**

- 1. Bidder should submit supporting documents in support of the above technical criteria:
  - a) PO / Contract/ LOA copy; and
  - b) Completion certificate from Client
  - c) Any relevant Document from Client certifying minimum building(s) built-up area of 15000 sqm along with associated infrastructure facilities.
  - d) Document in support of office in Gujarat. Bidder can submit registered rent agreement or electricity bill with Bidder's Name or Declaration on non-judicial stamp paper duly notarized or any other relevant document.
  - e) Copy of valid registration from council of Architecture constituted by Govt. of India Under the provision of the Architects Act, 1972.
- 2. All documents in support of Technical Criteria of BEC to be furnished by the bidders shall necessarily be duly certified/ attested by:
  - a) For Indian bidder: duly certified/ attested by Chartered Engineer and notary public with legible stamp.
- 3. Jobs executed by subsidiary/fellow subsidiary/Holding company:

A job executed by a bidder for its own plant/projects cannot be considered as experience for the purpose of meeting the requirements of BEC of the tender. However, jobs executed for subsidiary / fellow subsidiary / Holding company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice(s) duly certified by Statutory Auditor of the bidder towards payment of statutory tax in support of the job executed for subsidiary / fellow subsidiary / Holding company. Such bidders are required to submit these documents in addition to the documents specified in the bidding documents to meet BEC of the tender.

### **Documents in support of Financial Criteria**

- 4. All relevant document submitted in support of financial criteria shall be duly certified by statutory Auditor of the Bidder or Independent Chartered Accountant with his seal/signature.
- 5. If the bidder's working capital is negative or inadequate, then such bidder shall submit a letter from any scheduled commercial bank, as per RBI Act, 1934, confirming the availability of the line of credit to cover working capital requirement specified above, as per the format provided in tender document.
- 6. "Net worth" means the aggregate value of the paid-up share capital and all reserves created out of the profits and securities premium account, after deducting the aggregate value of the accumulated losses, deferred expenditure and miscellaneous expenditure not written off, as per the audited balance sheet, but does not include reserves created out of revaluation of assets, write-back of depreciation and amalgamation.
