



**NOTICE INVITING TENDER (NIT) FOR SELECTION OF SUPPLIER FOR SUPPLY OF
All-IN-ONE DESKTOP
AT PETRONET LNG LIMITED, DAHEJ (GUJARAT) INDIA**

Petronet LNG Limited (PLL), a company promoted by Bharat Petroleum Corporation Limited (“**BPCL**”), GAIL (India) Limited (“**GAIL**”), Indian Oil Corporation Limited (“**IOC**”) and Oil & Natural Gas Corporation Limited (“**ONGC**”), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for “SUPPLY OF ALL-IN-ONE DESKTOP” at Petronet LNG Limited, Dahej Terminal. Bids to be submitted in accordance with the Tender Document reference no: PLL/DHJ/IT/9443/2022-23

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

Bid Evaluation Criteria (BEC)

A. Financial

1. The annual turnover of the Bidder shall be minimum ₹ 1,00,00,000.00 (Indian Rupees One Crore Only) in any one of the 3 (three) preceding Audited Financial Years. The Bidder shall submit balance sheet and profit and loss account duly certified/attested by notary public with legible stamp in support of this.
2. Net worth of the bidder should be positive as per the Balance Sheet of the latest Audited Financial Year.
3. Working Capital of the bidder should be minimum ₹ 20,00,000.00 (Indian Rupees Twenty Lakh Only) as per the audited Balance Sheet of the latest Audited Financial Year, in the absence of which a line of credit from the Bank shall be submitted.

Note:

Documents in support of Financial Criteria

1. Details be provided as per Form-9-B of the tender document.

B. Technical

Bidder should be manufacturer of HP/Dell/Lenovo Make or their authorized distributor / agent. In case of authorized distributor/agent, bidder to attach updated and valid authorization letter from Original Equipment Manufacturer (OEM) along with the techno-commercial bid.

Note:

Documents in support of Technical Criteria

1. The documents in support of the technical criteria shall be duly certified/ attested by Chartered Engineer and Notary public with legible stamp.
2. A job executed by a Bidder for its own plant/projects cannot be considered as experience for the purpose of meeting requirement of BEC of the tender. However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice(s) duly certified by statutory Auditor of the Bidder towards payments of statutory tax in support of the job executed for Subsidiary/ fellow subsidiary / Holding company. Such Bidders to submit these documents in addition to the documents specified in the bidding documents to meet BEC.
