

NOTIFICATION OF TENDER FOR SELECTION OF CONTRACTOR FOR CONSTRUCTION OF AFFORDABLE RENTAL HOUSING COMPLEX (ARHC) AT EKSAL VILLAGE, BHARUCH, GUJARAT

Petronet LNG Limited, a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bid through Domestic Competitive Bidding (DCB) from prospective bidders to submit their qualification proposals in accordance with bidding document (**PLLDELPR000452022**), for selection of Contractor for "Construction of Affordable rental housing complex (ARHC) at Eksal village, Bharuch, Gujarat".

A bid satisfying the requirements of bid eligibility/ evaluation criteria stated herein shall be evaluated for techno-commercial eligibility. Any bid not satisfying the following techno-commercial eligibility criteria shall be liable for rejection:

a) Technical Criteria

Bidder should have successfully completed ONE Similar Work of minimum value of ₹43 crore exclusive of taxes against a single work order during last seven years ending on previous day of the last date of submission of Bids.

NOTE: Similar Work as mentioned above in the technical eligibility criteria means "Composite works under one contract for Construction of residential housing complex(es), group housing project(s), commercial or institutional buildings comprising of Civil, plumbing and Electrical works".

b) Financial Criteria

- a) The minimum average annual financial turnover of the Bidder shall be INR 22 crore (Indian Rupees Twenty-Two Crore only) in any of the preceding three audited financial years prior to the prescribed Bid submission date i.e. 2019-20, 2020-21 and 2021-22.
- b) Net worth of the Bidder shall be positive as per the last audited financial statement as on 31st March 2022.
- c) Working Capital of the Bidder must be minimum of INR 4.3 crore (Indian Rupees Four Crore and Thirty lakh only) in last audited financial year as on 31st March 2022.

Documents in support of Technical Criteria:

- 1) Bidder shall submit following documents in support of the Technical Bid Eligibility Criteria (BEC).
 - a) PO / LOA/ Work Order /Contract copy.
 - b) Execution/ Experience/ Completion Certificate from Client of required value.

- c) Any relevant document/ BOQ from client specifying the similar type of works (Civil, Plumbing and Electrical) carried by the bidder for the qualifying Work Order.
- d) For work done as sub-contractor, necessary documentary evidence from client / end user for carrying out works as approved sub-contractor.
- 2) All documents in support of technical criteria (mentioned in above points 1) of Bid Evaluation Criteria (BEC) furnished by the Bidder shall further be verified and certified by any one of the following independent third-party inspection agency:
 - (i) Societe Generale de Surveillance (SGS)
 - (ii) Gulf Lloyds Industrial Services (India) Pvt. Ltd (GLJS)
 - (iii) International Certification Services (JCS)
 - (iv) Bureau Veritas (Ind) Pvt. Ltd (BVIS)
 - (v) TUV SUD (FUV).
 - (vi) Det Norske Veritas (DNV)
 - (vii) Certification Engineers International Ltd. (CEIL)
 - (viii) Lloyds Register Industrial Services (LRIS)

All charges of the third party for verification and certification shall be borne by the Bidder.

3) Jobs executed by Subsidiary/ Fellow Subsidiary/ Holding Company:

A job executed by a bidder for its own plant/ projects cannot be considered as experience for the purpose of meeting the requirements of BEC of the tender. However, jobs executed for subsidiary/ fellow subsidiary/ holding company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice(s) duly certified by Statutory Auditor of the bidder towards payment of statutory tax in support of the job executed for subsidiary/ fellow subsidiary/ holding company. Such bidders are required to submit these documents in addition to the documents specified in the bidding documents to meet BEC of the tender.

Documents in support of Financial Criteria:

- All relevant document submitted in support of financial criteria shall be duly certified by statutory
 Auditor of the Bidder or Independent Chartered Accountant with his seal/signature and UDIN
 number.
- 2. If the bidder's working capital is negative or inadequate, then such bidder shall submit a letter from any scheduled commercial bank, as per RBI Act, 1934, confirming the availability of the line of credit to cover working capital requirement specified above, as per the format provided in tender document.
- 3. "Net worth" means the aggregate value of the paid-up share capital and all reserves created out of the profits and securities premium account, after deducting the aggregate value of the accumulated losses, deferred expenditure and miscellaneous expenditure not written off, as per the audited balance sheet, but does not include reserves created out of revaluation of assets, write-back of depreciation and amalgamation.
