



NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR PROVIDING SERVICES OF PLANT PAINTING FOR ONE YEAR AT PETRONET LNG LTD, KOCHI, (KERALA) INDIA

Petronet LNG Limited, a company promoted by Bharat Petroleum Corporation Limited (**"BPCL"**), GAIL (India) Limited (**"GAIL"**), Indian Oil Corporation Limited (**"IOC"**) and Oil & Natural Gas Corporation Limited (**"ONGC"**), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from prospective bidders for **"Plant painting work for a Period Of One Year"** at M/s. Petronet LNG Limited-Kochi. Bids to be submitted in accordance with the Tender Document reference no: **PLL/KOCHI/ME/SER/5971/2022-23**

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

BID EVALUATION CRITERIA (BEC):

Commercial:

1. The bidder should submit Earnest Money Deposit (EMD) for an amount of Rs. 327,500/- (Indian Rupees Three Lakh Twenty Seven Thousand and Five Hundred Only) in the form of Demand Draft or Bank Guarantee in favour of Petronet LNG Ltd. payable at Kochi branch. The Bank Guarantee should be from a scheduled / Nationalized bank. The bidder can submit this EMD amount through online payment (either IMPS/ RTGS/ NEFT).
2. The annual turnover of the Bidder shall be minimum of Rs. 109,00,000/- (Indian Rupees One Crore and Nine Lakh Only) during any of the financial year 2018-19, 2019-20 and 2020-21. The Bidder shall submit audited annual financial statements along with ITR copies duly signed by statutory auditor for the last 3 years.
3. Net worth of the Bidder should be positive during financial year ending 2020-21.
4. The bidder shall have minimum working capital of Rs. 21,00,000/- during financial year ending 2020-21. In the absence of minimum working capital, bidder shall provide a letter confirming the availability of line of credit for at least Rs. 21,00,000/- from bidder's bank having Net worth of not less than Rs.100 crore.

Notes:-

- a. The format for "Financial capability of bidder" (at Appendix O) shall be submitted duly signed and stamped by chartered accountant in Original.
- b. Further, copy of annual audited financial statements shall be submitted duly certified/attested by notary stamp with legible stamp.

Technical:

1. The Bidder should have following similar work experience (**) during last Seven years, the last 7 (Seven) years shall be counted from the last day of bid submission date:

i. One (01) similar contract of value not less than Rs. 1,09,00,000/-.

(**) *Similar Work shall mean carrying out painting in Hydro Carbon Industry of ;*

- a. Marine structure OR
- b. Offshore platform & piping OR
- c. Terminal structures& piping OR
- d. Process plant structures &piping OR
- e. Vertical structures OR
- f. Vessels.

2. Bidder shall provide declaration on its letter head:

- a) **If the Bid is being submitted by Paint manufacturer and job will be done by the Paint Manufacturer directly:** To depute one number of NACE level 2 Paint Manufacturer's Full-Time Inspector having 2-3 Years of experience in painting field at PLL site for the complete contract duration. The Copy of NACE certification and Bio Data of the Paint Manufacturer's Full-Time Inspector to be submitted. (Format attached at Appendix Q)
- b) **If the Bid is being submitted by Paint applicator/contractor:** To depute one number of NACE level 2 Paint Manufacturer's Full-Time Inspector at PLL site having 2-3 Years of experience in painting field for the complete contract duration. A Copy of NACE certification and Bio Data of the Paint Manufacturer's Full-Time Inspector to be submitted (Format attaché at Appendix Q).
- c) If the Bid is being submitted by Paint applicator/contractor, authorization letter/certificate shall be submitted from the Paint Manufacturer for technical evaluation of the bid. (Format attaché at Appendix P).

Notes:-

- a) The Bidder shall submit work/service order copy(ies) **and** their completion certificate(s) in the support of the above **duly certified/attested by chartered engineer and notary public with legible stamp. A submission of job completion certificate is mandatory.**

Both order copy and its completion certificate needs to be certified/attested by chartered engineer along with notary public with legible stamp.

- b) If the bidder is executing rate / maintenance / service contract which is still running and the contract value executed prior to due date of bid submission is equal to or more than the minimum prescribed value in the BEC such experience will also be taken in to consideration provided that the bidder has submitted satisfactory work / supply / service execution certificate issued by the end user.

Non-submission of the requisite certificates/documents shall render the bid non-responsive and shall be liable for rejection.
