



## **NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR ANNUAL RATE CONTRACT FOR HIRING OF TAXI SERVICES FOR A PERIOD OF 2+1 YEARS AT PETRONET LNG LIMITED, DAHEJ (GUJARAT) INDIA**

**Petronet LNG Limited (PLL)**, a company promoted by Bharat Petroleum Corporation Limited (“BPCL”), GAIL (India) Limited (“GAIL”), Indian Oil Corporation Limited (“IOC”) and Oil & Natural Gas Corporation Limited (“ONGC”), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for “**ARC for hiring of Taxi Services for a period of 2+1 Years**” at Petronet LNG Limited, Dahej Terminal. Bids to be submitted in accordance with the Tender Document reference no: PLL/DHJ/HR/9729/2022-23

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected:

### **Bid Evaluation Criteria (BEC)**

#### **A. Financial**

1. The bidder should submit Earnest Money Deposit (EMD) for an amount of INR 8,41,200.00 (Indian Rupees Eight Lakh Forty One Thousand and Two Hundred Only).
2. The annual turnover of the Bidder shall be minimum INR 93,50,000.00 (Indian Rupees Ninety Three Lakh and Fifty Thousand Only) in any one of the 3 (three) preceding Audited Financial Years.
3. Net worth of the bidder should be positive as per the Balance Sheet of the latest Audited Financial Year.
4. Working Capital of the bidder should be minimum INR 18,70,000.00 (Indian Rupees Eighteen Lakh and Seventy Thousand Only) as per the Balance Sheet of the latest Audited Financial Year, in the absence of which a line of credit from the Bank shall be submitted.

#### **B. Technical**

1. The bidder should have experience of at least one similar work (\*) of value not less than INR 93,50,000.00 (Indian Rupees Ninety Three Lakh and Fifty Thousand Only) in previous 7 (seven) years. The previous 7 (seven) years shall be counted from the last day of bid submission date.

(\*) Definition of “Similar Work”

“providing taxi/ car transportation services in/for any industrial setup”

The Bidder shall submit LOA/ Work / Service Order copy(ies) and their completion certificate(s) in the support of the above.

2. The bidder must have 06 (six) light commercial vehicles in the name of bidder/partner/proprietor. The registered vehicle should not be older than 01<sup>st</sup> January 2020. Documentary evidence in the form of RC book & Insurance details in this regard is to be submitted.

**Note:**

Documents in support of Technical Criteria

1. The documents in support of the technical criteria shall be duly certified/attested by Chartered Engineer and Notary public with legible stamp.
2. A job executed by a Bidder for its own plant/projects cannot be considered as experience for the purpose of meeting requirement of BEC of the tender. However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice(s) duly certified by statutory Auditor of the Bidder towards payments of statutory tax in support of the job executed for Subsidiary/ fellow subsidiary / Holding company. Such Bidders to submit these documents in addition to the documents specified in the bidding documents to meet BEC.
3. In case, the bidder is executing rate / maintenance / service contract which is still running and the contract value / quantity executed prior to due date of bid submission is equal to or more than the minimum prescribed value, such experience will also be taken in to consideration provided that the bidder has submitted satisfactory work / supply / service execution certificate issued by the end user.
