

# NOTIFICATION OF TENDER DOCUMENT FOR SUPPLY, INSTALLATION, TESTING & COMMISSIONING OF SELF-PROPELLED, ELECTRICALLY POWERED, ARTICULATING, CRAWLER AERIAL PLATFORM LIFT AT PETRONET LNG LTD, NEW DELHI.

Petronet LNG Ltd. is constructing its office building at Sector 14, Dwarka, New Delhi. The Dwarka office building has an aspirational ship-shape design made up of structural steel, cable net glazing system and high-performance glass façade. To maintain the aesthetics of a full glass façade building, regular cleaning of the glass facade will be required. Since, the building façade is curved in both the planes the installation of conventional roof mounted façade cleaning system is inadequate for Dwarka Building.

Based on the feedback of experienced façade cleaning agencies regarding possible cleaning schemes, it was decided to procure an aerial platform lift through an OEM or their authorized distributor/dealer/representative. The company invites bids under single stage two-bid system for supply, testing & commissioning of self-propelled, electrically powered, articulating, crawler aerial platform lift at Petronet LNG Limited to submit their bid in accordance with Tender Document (PLLDELPR000202023).

For selection of bidders, Eligibility Criteria is described below. The Bidder should meet the following Techno Commercial Criteria and any Bidder not meeting the same will be rejected.

#### Bid Eligibility Criteria (BEC) for Procurement of Aerial Platform Lift for Dwarka Building.

The Bidder should meet the following Techno - Commercial Criteria and any Bidder not meeting the same, will be rejected.

#### 1. Technical Criteria

The Bidder should be an OEM or an authorized distributor/dealer/representative of the OEM of the tendered item meeting the following eligibility criteria:

- a) The Bidder (in case the OEM itself is Bidder) or manufacturer of the Bidder (in case authorized distributor/dealer/representative of OEM is the Bidder) should have experience of 05 year of manufacturing and supply (either direct or through distributors/dealer/representative) of tendered item.
- b) Bidder should have successfully executed ONE Similar single order of minimum value of ₹62.2. Lakh during last 5 years ending on previous day of the last date of submission of Bid.
- c) The Bidder should have all the type-test certificates of tendered item as per specifications issued by OEM. The type-test certificates of the tendered item shall not be older than 5 years ending on previous day of the last date of submission of Bid.

Note: -

- i. **Tendered item or Similar item** as mentioned above in the technical eligibility criteria means a Self-Propelled, electrically powered articulating crawler Aerial Platform Lift for facade cleaning activities having the following characteristics:
  - a) Ability to reach working height of 24 m
  - b) Rotatable cage capable of carrying minimum 200 kg load.
  - c) Turret mounted articulate boom
  - d) Crawler Tracks
- ii. In case authorized Distributor / Dealer /Representative is participating in the tender on behalf of one manufacture, is not allowed to participate/ quote on behalf of any other manufacture in this tender.
- iii. If original equipment manufacturer (OEM) is participating in the tender. In such cases, authorized Distributor/ Dealer /Representative of OEM shall not be allowed to participate in this tender.

# **Documents in support of Technical Criteria:**

- 1) Bidder shall submit all the documents in support of the Technical Bid Eligibility Criteria (BEC) duly certified/attested by Independent Chartered Engineer / Notary Public with his legible seal and signature.
- 2) Following documents shall be submitted in support of technical Bid Eligibility criteria (BEC):
  - a) PO / LOA/ Work Order /Contract copy.
  - b) Execution/ Experience/ Completion Certificate from Client of required value.
  - Copy of Certificate of Incorporation from the respective Government body, (In case of OEM) & Dealership Enlistment Certificate (In case of distributor/Dealer/Representative).

#### 2. Financial Criteria

- 2.1 The turnover of the Bidder shall be minimum Rs.62,20,000/- (INR Sixty Two Lakh Twenty thousand only) per annum during any one of the preceding three financial years prior to the prescribed Bid submission date (i.e., 2019-20, 2020-21 & 2021-22).
- 2.2 The bidder must have positive net worth as per the last audited financial statement as on March 2022 Bidder is also required to submit the certificate of positive net worth as on 31st March 2022.
- 2.3 The working capital of the bidder for preceding financial year shall be Rs. 12,40,000/-(INR Twelve Lakh Forty Thousand only).

### **Documents in support of Financial Criteria:**

- a) All relevant document submitted in support of financial criteria shall be duly certified by independent Chartered Accountant with his legible seal and signature and UDIN number.
- b) If the Bidder's working capital is negative or inadequate, then such Bidder shall submit

- a letter from any scheduled bank confirming the availability of the line of credit to cover working capital requirement specified above.
- c) "Net worth" means the aggregate value of the paid-up share capital and all reserves created out of the profits and securities premium account, after deducting the aggregate value of the accumulated losses, deferred expenditure and miscellaneous expenditure not written off, as per the audited balance sheet, but does not include reserves created out of revaluation of assets, write-back of depreciation and amalgamation.

## 3. Jobs executed by Subsidiary/ Fellow Subsidiary/ Holding Company:

3.1 A job executed by a bidder for its own plant/ projects cannot be considered as experience for the purpose of meeting the requirements of BEC of the tender. However, jobs executed for subsidiary/ fellow subsidiary/ holding company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice(s) duly certified by Statutory Auditor of the bidder towards payment of statutory tax in support of the job executed for subsidiary/ fellow subsidiary/ holding company. Such bidders are required to submit these documents in addition to the documents specified in the bidding documents to meet BEC of the tender.
