



NOTIFICATION OF TENDER FOR SELECTION OF CONTRACTOR FOR OFFSHORE GEOTECHNICAL INVESTIGATIONS AND GEOPHYSICAL SURVEY WORKS FOR LNG TERMINAL AT GOPALPUR ODISHA

Petronet LNG Limited, a company promoted by Bharat Petroleum Corporation Limited (“**BPCL**”), GAIL (India) Limited (“**GAIL**”), Indian Oil Corporation Limited (“**IOC**”) and Oil & Natural Gas Corporation Limited (“**ONGC**”), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bid through Domestic Competitive Bidding (DCB) from prospective bidders to submit their qualification proposals in accordance with bidding document (**PLLELPR000222023**), for selection of Contractor for “Appointment of Contractor for Offshore Geotechnical Investigations and Geophysical Survey Works for LNG terminal at Gopalpur Odisha”.

A bid satisfying the requirements of bid eligibility/ evaluation criteria stated herein shall be evaluated for techno-commercial eligibility. Any bid not satisfying the following techno-commercial eligibility criteria shall be liable for rejection:

a) Technical Criteria

- a. *The Bidder should have successfully completed at least one Work related to Marine Geotechnical Investigation (involving use of jack up barge/ geotechnical drillship/vessel inclusive of drilling rig) and Marine Geophysical Survey in last 7 years under single or multiple contracts for any jetty, harbour, port or marine works as per details given in the commercial criterion. The requisite dates shall be reckoned from the last date of bid submission (Original bid due date). Even in case the date of bid submission is extended, the date originally considered as reference date for experience criteria, shall remain unchanged.*
- b. *In case bidder does not have the requisite experience with respect to Marine Geophysical survey as an inhouse capability, it can engage a sub-contractor provided having similar experience as detailed above in the past 7 years as on original bid due date. Even in case the date of bid submission is extended, the date originally considered as reference date for experience criteria, shall remain unchanged.*
- c. *The Bidder should have similar experience, during any of the last seven years from the last date of bid submission (original Bid due date). Even in case the date of bid submission is extended, the date originally considered as reference date for experience criteria, shall remain unchanged. The value of completed work for evaluation shall be considered as under:*

I. *Three similar Marine Geotechnical works each costing not less than the INR 1.36 Crore, excluding taxes.*

OR

II. *Two similar Marine Geotechnical works each costing not less than the INR 1.84 Crore, excluding taxes.*

OR

III. *One similar Marine Geotechnical works costing not less than the INR 2.26 Crore, excluding taxes.*

A. Financial criteria

- i. *The minimum average annual financial turnover of the Bidder shall be ₹2.26 crore (Indian Rupees Two Crore and Twenty-Six Lakh only) in any of the preceding three audited financial years prior to the prescribed Bid submission date i.e. 2019-20, 2020-21 and 2021-22.*
- ii. *Net worth of the Bidder shall be positive as per the last audited financial statement as on 31st March 2022.*
- iii. *Working Capital of the Bidder must be minimum ₹0.45 crore in last audited financial year as on 31st March 2022.*

Documents in support of Technical Criteria:

- 1) *Bidder shall submit following documents in support of the Technical Bid Evaluation Criteria (BEC) duly certified/attested by independent chartered engineer and notary public with his legible seal and signature.*
 - a) *PO / LOA/ Work Order /Contract copy.*
 - b) *Execution/ experience/ completion certificate from client/end user.*
 - c) *Any relevant document from client specifying the type of works carried by the bidder for the qualifying work order.*
- 2) *Jobs executed by subsidiary/fellow subsidiary/holding company:
A job executed by a bidder for its own plant/projects cannot be considered as experience for the purpose of meeting the requirements of BEC of the tender. However, jobs executed for subsidiary / fellow subsidiary / holding company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice(s) duly certified by statutory auditor of the bidder towards payment of statutory tax in support of the job executed for subsidiary / fellow subsidiary / holding company. Such bidders are required to submit these documents in addition to the documents specified in the bidding documents to meet BEC of the tender.*

- 3) *Any work/purchase/service order executed for PLL by any Bidder will not require any certification from external parties (i.e. Chartered engineer and notary).*

Documents in support of Financial Criteria:

1. *Indian bidder: shall submit “Details of financial capability of bidder” in prescribed format duly signed and stamped by a chartered accountant with his seal/signature and UDIN number. Further copy of audited annual financial statements submitted in bid shall be duly certified/attested by notary public with legible stamp.*
2. *If the bidder’s working capital is negative or inadequate, then such bidder shall submit a letter from any scheduled commercial bank, as per RBI Act, 1934, confirming the availability of the line of credit to cover working capital requirement specified above, as per the format provided in tender document.*
3. *“Net worth” means the aggregate value of the paid-up share capital and all reserves created out of the profits and securities premium account, after deducting the aggregate value of the accumulated losses, deferred expenditure and miscellaneous expenditure not written off, as per the audited balance sheet, but does not include reserves created out of revaluation of assets, write-back of depreciation and amalgamation.*
