

NOTIFICATION OF TENDER DOCUMENT FOR SELECTION OF AGENCY FOR PROVIDING SECURITY SERVICES AT PETRONET LNG LIMITED, NEW DELHI

Petronet LNG Limited, a company with its registered office at World Trade Centre, 1st Floor, Babar Road, Barakhamba Lane, New Delhi, 110 001, India, incorporated in April, 1998 under the provisions of the (Indian) Companies Act, 1956 ("**PLL**" or the "**Company**") and promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOCL**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India. Its shares are listed on the Bombay Stock Exchange and the National Stock Exchange of India

The company invites bids under single stage two-bid system for "Selection of Security Service Agency at PLL, New Delhi" to submit their bid in accordance with Tender Document (PLLDELHR000582023).

Bid Eligibility Criteria (BEC) – Selection of Contractor

For selection of bidders, Eligibility Criteria is described below. The Bidder should meet the following Techno Commercial Criteria and any Bidder not meeting the same will be rejected.

A. Technical Criteria:

- 1) The bidder should have any of the following experience of similar work (*) in previous 7 (seven) years. The previous 7 (seven) years shall be counted from the last day of bid submission date (Kindly refer Note Point-iv of Notes given below).
 - a. One similar completed works each costing not less than the amount equal to Rs. 1.42 Cr exclusive of GST **OR**
 - b. Two similar completed works each costing not less than the amount equal to Rs. 1.15 Cr exclusive of GST **OR**
 - c. Three similar completed works each costing not less than the amount equal to Rs. 86 lakh exclusive of GST.
 - (*) Definition of "Similar Work" "Providing Security Services of engaging minimum 50 security personnel. The Bidder shall submit PO/LOA/ Work / Service Order copy (ies) and their completion certificate(s) in the support of the above *duly certified/ attested by Chartered Engineer and notary public with legible stamp*.
- 2) The Bidder must have its office in Delhi/NCR. The Bidder should provide an undertaking to this effect (specifying the location, number of technical resources and contact number of such centre (s)) must be submitted on bidder's letterhead by its Company Secretary or Director or CTO or CFO or Partner.

- 3) The Bidder must have ISO certification for providing security services in last seven years (i.e., 2016-17, 2017-18, 2018-19, 2019-20, 2020-21, 2021-22, 2022-23). Bidder should submit ISO 9000/ 9001 certificate for each year in support of the same. The Bidder should provide the copy of the ISO Certification duly certified/ attested by Chartered Engineer and notary public with legible stamp.
- 4) Bidder must provide Certificate of Incorporation / Shops & Establishment Registration, PF Registration, ESIC Registration. Bidder must also provide Labour Licence for previous seven years (i.e., 2016-17, 2017-18, 2018-19, 2019-20, 2020-21, 2021-22, 2022-23). The Bidder should provide the copy of the Certificate of incorporation issued by Registrar of Companies/ Partnership Deed duly certified/ attested by Chartered Engineer and notary public with legible stamp.
- 5) Bidder must provide certificate from CA of timely submission of dues / returns for PF & ESIC of last financial year (FY 2022-23) for all its personnel's. *Bidder to submit Certificate duly certified by Chartered Accountant*.

Note: Documents in support of Technical Criteria

- i. The documents in support of the technical criteria shall be duly certified/ attested by Chartered Engineer and Notary public with legible stamp. However, any work/purchase/service order executed for PLL by any Bidder will not require any certification from external parties (i.e. Chartered engineer, notary or any third party agency).
- ii. The amount(s) as indicated above shall be exclusive of GST/indirect taxes for arriving at Single/ Two/ Three Completed work order values.
- iii. A job executed by a Bidder for its own offices cannot be considered as experience for the purpose of meeting requirement of BEC of the tender. However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice(s) duly certified by statutory Auditor of the Bidder towards payments of statutory tax in support of the job executed for Subsidiary/ fellow subsidiary / Holding company. Such Bidders to submit these documents in addition to the documents specified in the bidding documents to meet BEC.
- iv. Even in case the date of bid submission is extended, the date originally considered as reference date for experience criteria, shall remain unchanged.

B. Financial Criteria:

- 1) The annual turnover of the Bidder shall be minimum Rupees 2.50 Crore (Rs. Two Crore Fifty lakhs only) in each of the preceding three financial years prior to the prescribed Bid submission date (i.e., 2020-21, 2021-22, 2022-23).
- 2) Net worth of the bidder should be positive for financial year 2022-23.
- 3) Working Capital of the Bidder must be more than Rs.1.50 Crore as on 31st March 2023.
