



NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR KITCHEN RENOVATION WORK AT PETRONET LNG LTD, KOCHI, (KERALA) INDIA

Petronet LNG Limited, a company promoted by Bharat Petroleum Corporation Limited (“BPCL”), GAIL (India) Limited (“GAIL”), Indian Oil Corporation Limited (“IOC”) and Oil & Natural Gas Corporation Limited (“ONGC”), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from prospective bidders for “**Kitchen Renovation work**” at M/s. Petronet LNG Limited-Kochi. Bids to be submitted in accordance with Tender Document reference no: **PLL/KOCHI/ME/SER/6539-R/2023-24**

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

BID EVALUATION CRITERIA (BEC):

1. Financial:

- 1.1. The annual turnover of the Bidder shall be minimum Rs. 74,00,000/- (Indian Rupees Seventy Four Lakh Only) during any of the financial year 2019-20, 2020-21 and 2021-22. The Bidder shall submit audited annual financial statements along with ITR copies duly signed by statutory auditor for the last 3 years.
- 1.2. Net worth of the Bidder should be positive during financial year ending 2021-22.
- 1.3. The bidder shall have minimum working capital of Rs. 14,78,000/- during financial year ending 2021-22. In the absence of minimum working capital, bidder shall provide a letter confirming the availability of line of credit for at least Rs. 14,78,000/- from bidder's bank having Net worth of not less than Rs. 100 crore.

Requirements for Financial Criteria: -

- i. The format for “Financial capability of bidder” (at Appendix D) shall be submitted duly signed and stamped by chartered accountant in Original.
- ii. Further, copy of annual audited financial statements shall be submitted duly certified/attested by notary stamp with legible stamp.

2. Technical:

- 2.1 The Bidder should have following similar work experience (*) during last 7 (Seven) years; the last 7 (Seven) years shall be counted from the last day of bid submission date:
 - (a) One (01) similar contract of value not less than Rs. 63 Lakh OR,
 - (b) Two (02) similar contracts of value not less than Rs. 50.00 Lakh each OR,
 - (c) Three (03) similar contracts of value not less than Rs. 38 Lakh each

(*) Definition of “Similar Work” – Construction / Civil related Work in any industrial setup

- 2.2 Bidder should have successfully completed at least one work of “setting up / renovation of industrial kitchen / cafeteria” of any value in any one of previous 7 (seven) years. The previous 7 (seven) years shall be counted from the last day of bid submission date. The Bidder shall submit LOA/ Work / Service Order copy (ies) (including extensions, if any) and their completion certificate(s) in the support of the above.

Requirements for Technical Criteria: -

- i. The Bidder shall submit work/service order copy(ies) and their completion certificate(s) in the support of the above duly certified/attested by chartered engineer and notary public with legible stamp.
 - a. Both order copy and its completion certificate needs to be certified/attested by chartered engineer along with notary public with legible stamp.
 - b. The completion certificate shall have order details like order No., completion date and completed amount very clearly.
 - c. In case bidder submit LOA or order copy and its completion certificate of PLL as work experience, certified/attested by chartered engineer and notary public with legible stamp of the PLL documents shall not be required
- ii. The amount(s) as indicated above shall be exclusive of GST/indirect taxes for arriving at Single/ Two/ Three completed work order values.
- iii. Even in case the date of bid submission is extended, the date originally considered as reference date for experience criteria, shall remain unchanged.
- iv. If the bidder is executing rate / maintenance / service contract which is still running, and the contract value executed prior to due date of bid submission is equal to or more than the minimum prescribed value in the BEC such experience will also be taken in to consideration provided that the bidder has submitted satisfactory work / supply / service execution certificate issued by the end user.
- v. A job executed by a Bidder for its own plant/projects cannot be considered as experience for the purpose of meeting requirement of BEC of the tender. However, jobs executed for Subsidiary/ Fellow subsidiary/ Holding company will be considered as experience for the purpose of meeting BEC subject to submission of tax paid invoice(s) duly certified by statutory Auditor of the Bidder towards payments of statutory tax in support of the job executed for Subsidiary/ fellow subsidiary / Holding company. Such Bidders to submit these documents in addition to the documents specified in the bidding documents to meet BEC.

OTHER MANDATORY REQUIREMENTS

Earnest Money Deposit (EMD) - To be submitted along with the Techno Commercial bid:

The bidder should submit Earnest Money Deposit (EMD) for an amount of Rs. 222,000/- (Indian Rupees Two Lakh and Twenty Two Thousand Only) in the form of Demand Draft or Bank Guarantee in favour of Petronet LNG Ltd. payable at Kochi branch. The Bank Guarantee should be from a scheduled / Nationalized bank. The bidder can submit this EMD amount through online payment (either IMPS/ RTGS/ NEFT).

Non-submission of the requisite certificates/documents shall render the bid non-responsive and shall be liable for rejection.
