Petronet LNG Limited, a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids under single stage two-bid system for Various Manpower Services from prospective bidders to submit their bid in accordance with Tender Document (PLL/DEL/C&P/HR/RFP/2018/SERVICE PROVIDER).

For selection of bidders, Eligibility Criteria is described below. The Bidder should meet the following Techno Commercial Criteria and any Bidder not meeting the same will be rejected.

Eligibility Criteria:

- 1. The bidder should be a Company registered under Indian Companies Act, 1956 or Company Act 2013 in existence for a minimum of 03 years on the date of issue of this tender. It should not be a consortium of firms/ companies.
- 2. The Bidder must have a license from concerned authorities under the Contract Labour (Abolition and Regulation) Act, 1970.
- 3. The Bidder should have experience of having executed at least a single order / Contract for providing manpower services / support & peripheral services for office works having minimum order value of Rupees 2.0 crore (Rs. Two Crore only) in previous 5 years period.
- 4. The turnover of the Bidder shall be minimum Rupees 2.0 Crore (Rs. Two Crores only) per annum during last consecutive three financial years with the CA certificate for similar work.
- 5. Net worth of the bidder must be positive as per the audited financials as on 31/03/2018 or 31/03/2017.
