

NOTICE INVITING TENDER (NIT) FOR ENGINEERING STUDY FOR PLANT RELIABILITY AT PETRONET LNG LTD., DAHEJ (GUJARAT) INDIA

Petronet LNG Limited, a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for "Engineering Study for Plant Reliability" at Petronet LNG Ltd., Dahej Gujarat (India). Bids to be submitted in accordance with the Tender Document reference no. PLL/DHJ/TC/7128/2018.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

Bid Evaluation Criteria (BEC)

Commercial

- 1. The Bidder shall submit Earnest Money Deposit (EMD) for an amount of INR 250,000/- (Indian Rupees Two Lakh Fifty Thousand only) in the form of Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd. The Bank Guarantee should be from a scheduled / Nationalized bank.
- 2. The average annual turnover of the Bidder in similar works shall be minimum INR 110,00,000/- (Indian Rupees One Crore Ten Lakh only) during the financial year 2014-15, 2015-16 and 2016-17. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial years duly certified by statutory auditor of the company. Net worth of the Bidder should be positive during preceding financial year.
- 3. Net worth of the Bidder should be positive during preceding financial year.
- 4. The Bidder should have following experience during last five years, the last 5 (five) years shall be counted from the last day of bid submission date.
- a) One (01) similar contract of value not less than INR 100 lakh or,
- b) Two (02) similar contracts of value not less than INR 50 lakh each or,
- c) Three (03) similar contracts of value not less than INR 35 lakh each.

 The Bidder shall submit work /service order copy (ies) and their completion certificate(s) in support of the above.

Technical

The Bidder should have Experience in design and engineering i.e. should have experience as Project Management Consultant (PMC) and/or Engineering, Procurement and construction (EPC) and/or preparation of FEED of an LNG liquefaction plant or regasification terminal of a minimum capacity

of 2.5 MMTPA, which has been successfully commissioned during the past 10 years. The last 10 years shall be counted from the last day of Bid Submission date.

Bidder shall attach copy of work order / client completion certificate (duly notarized) in support of the technical requirement as mentioned above.
