

NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR ANNUAL MAINTENANCE CONTRACT FOR HORTICULTURAL SERVICES AT PETRONET LNG LIMITED, DAHEJ

Petronet LNG Limited (PLL), a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for "Annual Maintenance Contract for Horticultural Services" at PLL's Dahej LNG Terminal at Gujarat (India). Bids to be submitted in accordance with the Tender Document reference no. PLL/DHJ/HO/7872/2019.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

Bid Evaluation Criteria (BEC)

A. Commercial

- 1. The Bidder shall submit Earnest Money Deposit (EMD) for an amount of INR 2,42,000/- (Rupees Two Lakh and Forty Two Thousand Only) in the form of Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd. The Bank Guarantee should be from a scheduled / Nationalized bank.
 - Firms registered with NSIC will be exempted from payment of Earnest money/Bid Bond provided they are registered upto the monetary limits and for the items they intend to quote against PLL tender.
- 2. The average annual turnover of the Bidder in similar works shall be minimum INR 55,00,000/- (Rupees Fifty Five Lakh Only) during the Financial year 2015-16, 2016-17 and 2017-18. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial years duly certified by statutory auditor of the company.
- 3. Net worth of the Bidder should be positive during preceding financial year.
- 4. The bidder should have following work experience having similar nature of work during last 5 years. The last 5 (five) years shall be counted from the last day of bid submission date:
 - a) One (01) similar contract of value not less than INR 91 Lakh or,
 - b) Two (02) similar contracts of value not less than INR 46 Lakh each or,
 - c) Three (03) similar contracts of value not less than INR 31 Lakh each.

B. Technical

The bidder must have carried out one Annual Maintenance of Horticultural Services in Oil & gas Sector / Fertilizers / Petrochemical sector / Chemical plants of Govt. / PSE / Reputed Private companies in India during last 5 (five) years. The last 5 (five) years shall be counted from the last day of bid submission date.

The Bidder shall submit work /service order copy (ies) and / or, their completion certificate(s) in support of the above.
