

NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR PROVIDING TAXI SERVICE (ANNUAL RATE CONTRACT) AT BHARUCH FOR PETRONET LNG LIMITED, DAHEJ

Petronet LNG Limited (PLL), a company promoted by Bharat Petroleum Corporation Limited ("**BPCL**"), GAIL (India) Limited ("**GAIL**"), Indian Oil Corporation Limited ("**IOC**") and Oil & Natural Gas Corporation Limited ("**ONGC**"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for "Taxi Service (Annual Rate Contract) at Bharuch" for PLL's Dahej LNG Terminal at Gujarat (India). Bids to be submitted in accordance with the Tender Document reference no. PLL/DHJ/PO/7293/2018.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

Bid Evaluation Criteria (BEC)

Commercial

- 1. The Bidder shall submit Earnest Money Deposit (EMD) for an amount of INR 13,00,000/- (Indian Rupees Thirteen Lakh only) in the form of Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd. The Bank Guarantee should be from a scheduled / Nationalized bank.
- 2. The average annual turnover of the Bidder in similar works shall be minimum INR 3,60,00,000/-(Indian Rupees Three Crore and Sixty Lakh only) during the financial year 2014-15, 2015-16 and 2016-17. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial years duly certified by statutory auditor of the company.
- 3. Net worth of the Bidder should be positive during preceding financial year.
- 4. The Bidder should have following experience during last five years, the last 5 (five) years shall be counted from the last day of bid submission date.
 - a) One (01) similar contract of value not less than INR 500 lakh or,
 - b) Two (02) similar contracts of value not less than INR 260 lakh each or,
 - c) Three (03) similar contracts of value not less than INR 180 lakh each.

Technical

- 1. The bidder must have 05 light commercial vehicles (at least 2 Innova) registered in its name at the time of submission of the bid. The registration of the owned vehicles should not be older than 1st September,2012. Necessary copies of registration certificates shall be submitted along with technical bid.
- 2. Bidder must possess a valid registration of PF, ECIS and any other statutory license required under "The Motor Transport Worker Act 1961". Documentary evidence in support of the same shall be submitted along with technical bid.
