



NOTIFICATION OF TENDER DOCUMENT FOR SELECTION OF CONTRACTOR FOR SECURITY SERVICES AT PETRONET LNG LIMITED, NEW DELHI

Petronet LNG Limited, a company promoted by Bharat Petroleum Corporation Limited (“BPCL”), GAIL (India) Limited (“GAIL”), Indian Oil Corporation Limited (“IOC”) and Oil & Natural Gas Corporation Limited (“ONGC”), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids under single stage two-bid system for Security Service from prospective bidders to submit their bid in accordance with Tender Document (PLL/DEL/C&P/HR/2019/010).

For selection of bidders, Eligibility Criteria is described below. The Bidder should meet the following Techno Commercial Criteria and any Bidder not meeting the same will be rejected.

Eligibility Criteria required for Contractor

- 1.1 The Bidder should have experience of successfully executing at least one similar work contract (Security) of minimum value of **Rupees 90 Lakhs per year** (Rs. Ninety Lakhs only) in previous 5 years period (i.e. 2014-15, 2015-16, 2016-17, 2017-18 and 2018-19). Copy of work order should be submitted in support of the same.
- 1.2 The turnover of the Bidder shall be minimum **Rupees 90 Lakh** (Rs. Ninety Lakhs only) **per annum** during last consecutive three financial years (i.e. 2015-16, 2016-17 & 2017-18) with the CA certificate. Net worth of the bidder should be positive for latest financial year i.e. 2017-18.
- 1.3 The Bidder should have license from the Labour Commissioner as per the Section 12 of Chapter 4 of The Contract Labour (Regulation & Abolition) Act, 1970.
