



## **NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR MAINTENANCE DREDGING SERVICE AT PETRONET LNG LIMITED, DAHEJ**

**Petronet LNG Limited (PLL)**, a company promoted by Bharat Petroleum Corporation Limited (“BPCL”), GAIL (India) Limited (“GAIL”), Indian Oil Corporation Limited (“IOC”) and Oil & Natural Gas Corporation Limited (“ONGC”), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for “**Selection of Contractor for Maintenance Dredging Service**” at PLL’s Dahej LNG Terminal at Gujarat (India). Bids to be submitted in accordance with the Tender Document reference no. PLL/DHJ/PO/7826/2019.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

### **Bid Evaluation Criteria (BEC)**

#### **Commercial**

1. The bidder shall submit Earnest Money Deposit (EMD) for an amount of INR 13,80,000/- (Rupees Thirteen Lakh and Eighty Thousand only) in the form of Demand Draft or, Bank Guarantee in favor of Petronet LNG Ltd., Dahej. The Bank Guarantee should be from a scheduled / nationalized bank.  
  
Firms registered with NSIC will be exempted from payment of Earnest money/Bid Bond provided they are registered upto the monetary limits and for the items they intend to quote against PLL tender.
2. The average annual turnover of the Bidder in similar works shall be minimum INR 620,00,000/- (Rupees Six Crore and Twenty Lakh Only) during the financial years 2015-16, 2016-17 and 2017-18. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial year duly certified by statutory auditor of the company.
3. Net worth of the bidder should be positive during preceding financial year.
4. The bidder should have following similar work ( \* ) experience during last five years. The last 5 (five) years shall be counted from the last day of bid submission date:-
  - a) one similar contract of value not less than INR 520 Lakh or,
  - b) two similar contracts of value not less than INR 265 Lakh each or,
  - c) three similar contracts of value not less than INR 180 Lakh each

The Bidder shall submit work /service order copy (ies) and their completion certificate(s) in the support of the above.

#### **Technical**

- \* "Similar work" means dredging at one offshore location to achieve a depth of at least 12 meter below the Chart Datum (CD) under a single contract at a single site. The experience of only the bidding entity for the above similar work shall be considered for the Bidder’s Qualification Criteria. A job executed by the bidder for its own concern / subsidiary / holding company shall not be considered as experience for the purpose of meeting this Bid Evaluation Criteria.
1. In addition to above, the bidder or bidder’s Group Company or holding company shall own the following equipment as mentioned below:
    - a) At least one Trailing Suction Hopper Dredger with a minimum Hopper capacity of 4500 m<sup>3</sup> with valid certification. Details of dredger are to be submitted in the prescribed form given in



the tender documents. The bidder is required to submit valid Certificate of Registry issued by registration / certification agencies for the above equipment.

- b) In case the equipment as above are in the name of bidder's group company or holding company, the bidder is required to provide an irrevocable commitment letter from the Owner, along with the techno-commercial bid, stating that in the event of award of job to the bidder, such equipment shall be made available as per the requirement of the contract execution.

Further, in case the equipment as above are not in the name of the bidder or bidder's group company or holding company, the bidder is required to provide, along with the techno-commercial bid, either an 'Irrevocable letter of authority' from the Owner of the above equipment to the effect that the equipment shall be made available as per the requirement of the contract execution or confirmed chartering agreement for the duration of the proposed contract in case of award.
