



**NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR STUDY TO
MODIFY EXISTING RLNG SUPPLY HEADER AND STRESS ANALYSIS AT PETRONET
LNG LIMITED, DAHEJ (GUJARAT) INDIA**

Petronet LNG Limited (PLL), a company promoted by Bharat Petroleum Corporation Limited (“BPCL”), GAIL (India) Limited (“GAIL”), Indian Oil Corporation Limited (“IOC”) and Oil & Natural Gas Corporation Limited (“ONGC”), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The company invites bids from the prospective bidders for “**Study to Modify Existing RLNG Supply Header and Stress Analysis**” at Petronet LNG Limited, Dahej Terminal. Bids to be submitted in accordance with the Tender Document reference no. PLL/DHJ/TC/7862/2019.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

Bid Evaluation Criteria (BEC)

Commercial

1. The bidder shall submit Earnest Money Deposit (EMD) for an amount of INR 590,000/- (Rupees Five Lakh and Ninety Thousand only) in the form of Demand Draft or, Bank Guarantee in favor of Petronet LNG Ltd., Dahej. The Bank Guarantee should be from a scheduled / nationalized bank.

Firms registered with NSIC will be exempted from payment of Earnest money/Bid Bond provided they are registered upto the monetary limits and for the items they intend to quote against PLL tender.

2. The average annual turnover of the Bidder in similar works shall be minimum INR 265,00,000/- (Rupees Two Crore and Sixty Five Lakh Only) during the financial years 2015-16, 2016-17 and 2017-18. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial year duly certified by statutory auditor of the company.
3. Net worth of the bidder should be positive during preceding financial year.
4. The bidder should have following similar work experience during last five years. The last 5 (five) years shall be counted from the last day of bid submission date:-
 - a) one similar contract of value not less than ₹ 220 Lakh or,
 - b) two similar contracts of value not less than ₹ 112 Lakh each or,
 - c) three similar contracts of value not less than ₹ 75 Lakh each

The Bidder shall submit LOA / work /service order copy (ies) and their completion certificate(s) in the support of the above.

B. Technical

1. The bidder must have successfully executed at least one consultancy job for Optimization of Processes / Efficiency improvement / De- bottlenecking in Oil and Gas Sector/ Fertilizers/ Petrochemical sector in India or abroad in preceding five (05) years. Documentary evidence (Work



Order copy and completion certificate, final payment receipt etc.) in support of the same shall be provided along with the proposal duly attested by Authorized signatory of the company.

OR

The bidder should have experience in design and engineering (i.e. should have experience as Project Management Consultant (PMS) or Engineering, Procurement and construction (EPC) and preparation of FEED) of hydrocarbon industries in preceding 05 years. Documentary evidence (Work Order copy and completion certificate, final payment receipt etc.) in support of the same shall be provided along with the proposal duly attested by Authorized signatory of the company.

2. The bidder should have ISO 9000:2000 certification or equivalent quality management system certification.

Applicants with qualification / experience / certifications not relevant to the current requirement of engagement shall be excluded in the screening process. Decision of PLL in this regard shall be final and binding and no representation or correspondences will be entertained.
