



**NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR CLADDING REPLACEMENT FOR NORTH JETTY UNLOADING LINE AND PLANT AREA AT PETRONET LNG LIMITED, DAHEJ (GUJARAT) INDIA**

**Petronet LNG Limited (PLL)**, a company promoted by Bharat Petroleum Corporation Limited (“BPCL”), GAIL (India) Limited (“GAIL”), Indian Oil Corporation Limited (“IOC”) and Oil & Natural Gas Corporation Limited (“ONGC”), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

**Bid Evaluation Criteria (BEC)**

**Commercial**

1. The bidder shall submit Earnest Money Deposit (EMD) for an amount of ₹ 20,00,000/- (Rupees Twenty Lakh Only) in the form of Demand Draft or, Bank Guarantee in favor of Petronet LNG Ltd., Dahej. The Bank Guarantee should be from a scheduled/ nationalized bank.

Firms registered with NSIC will be exempted from payment of Earnest money/ Bid Bond provided they are registered upto the monetary limits and for the items they intend to quote against PLL tender.

2. The average annual turnover of the Bidder in similar works shall be minimum ₹ 580,00,000/- (Rupees Five Crore and Eighty Lakhs Only) during the financial years 2016-17, 2017-18 and 2018-19. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial year duly certified by statutory auditor of the company.

3. Net worth of the bidder should be positive during preceding financial year.

4. The bidder should have following similar work (\*) experience during last seven years. The last 7 (seven) years shall be counted from the last day of bid submission date:-

- a) one similar contract of value not less than ₹ 1000 Lakh or,
- b) two similar contracts of value not less than ₹ 550 Lakh each or,
- c) three similar contracts of value not less than ₹ 400 Lakh each

The Bidder shall submit LOA/ Work order/ Service order copy (ies) and their completion certificate(s) in the support of the above

- (\*) Similar work means - The bidder must have executed new / repair & maintenance of cold insulation work including Stainless steel cladding (Service Temperature: - 50 deg. C and below) for Piping / Equipment / Vessels / exchangers (which includes supply of insulation materials) in a reputed



Petrochemical Complex / Petroleum Refinery / Chemical plant / Fertilizer Plant / Gas Processing Complex / LPG Plant.
