



GLOBAL NOTIFICATION OF TENDER DOCUMENT FOR SELECTION OF CONTRACTOR FOR DESIGN , ENGINEERING, SUPPLY, ERECTION & COMMISSIONING OF LNG/LCNG DISPENSING STATION FOR PETRONET LNG LIMITED

Petronet LNG Limited, a company with its registered office at World Trade Centre, 1st Floor, Babar Road, Barakhamba Lane, New Delhi, 110 001, India, incorporated in April, 1998 under the provisions of the (Indian) Companies Act, 1956 (“**PLL**” or the “**Company**”) and promoted by Bharat Petroleum Corporation Limited (“**BPCL**”), GAIL (India) Limited (“**GAIL**”), Indian Oil Corporation Limited (“**IOC**”) and Oil & Natural Gas Corporation Limited (“**ONGC**”), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India. Its shares are listed on the Bombay Stock Exchange and the National Stock Exchange of India.

B	FINANCIAL CRITERIA
I.	Bidder's minimum Annual Turnover shall be Indian Rupees Seventeen Crore Fifty Lakh only (INR 17.5 Crore) for an Indian bidder or United States Dollar Two Million and Five Hundred Thousand only (USD 2.5 million) for foreign bidder in any of the preceding three financial years prior to the prescribed Bid submission date.
II.	Net worth of the Bidder should be positive as per the last audited financial statement for the financial year ended as on 31st March 2019 or calendar year ended as on 31st December 2018.
III.	Working Capital of the Bidder must be minimum INR 3.5 Crore in last audited financial year. If the Bidder's working capital is negative or inadequate, the Bidder shall submit a letter from any scheduled commercial bank, confirming the availability of the line of credit to cover working capital requirement specified above, as per the format provided in tender document.

Note: All relevant documents submitted in support of Financial Criteria of BEC shall be duly certified by statutory Auditor or independent Chartered Accountant with his seal/signature.
