### Construction of Boundary Wall, barbed wire fencing and installation of gates

#### Scope of Work

1. Construction of Compound Wall at Dahej Terminal-Expansion Area:- This shall include supply of all materials, tools tackle etc. required for completion of job, but not limited to the following works:
  - Excavation & Earthwork
  - Piling
  - PCC & RCC
  - Steel work & Reinforcement
  - Shuttering
  - Brickwork & Plastering
  - Painting
  - Site Cleaning and Handing over
2. Providing and fixing of Fencing at Dahej Terminal-Expansion Area:- This shall include supply of all materials, tools tackle etc. required for completion of job, but not limited to the following works:
  - Providing and application of all materials, with necessary manpower, equipment, tools and tackles.
  - Excavation/Area Clearing for fixing of RCC Pole.
  - Fixing of Precast RCC Pole with vertical and Horizontal Alignment.
  - Grouting of RCC Pole with necessary Shuttering.
  - Providing and Fixing of GI Chain link Fencing and Barbed wire with necessary accessories, tools and tackles.
  - Site Cleaning and Handing over
3. Providing and fixing of Electrically Operated gates at Dahej Terminal-Expansion Area:- This shall include supply of all materials, tools tackle etc. required for completion of job, but not limited to the following works:
  - Providing and application of all materials, with necessary manpower, equipment, tools and tackles.
  - All Civil/Foundation Work as per the Vendor Specification/ requirement.- Minimum requirement of opening and members details has been attached here for the contractor's better understanding; However contractor shall design the gate, necessary civil foundation, electrical requirement and installation shall be based on the final approved design basis only.-Providing and fixing of fabricated gate with vertical and Horizontal Alignment as per drawing. -All motors, switches, junction box which contain electric charge has to be flame proof.

#### **Minimum Bid Qualification Criteria**

Few important and mandatory criteria are mentioned below. The tender document contains complete list of Bid Evaluation Criteria

1. The bidder should submit Earnest Money Deposit (EMD) for an amount of ₹ 990,000/- (Rupees Nine Lakh Ninety Thousand Only) in the form of Demand Draft or Bank Guarantee. The Bank Guarantee should be from a scheduled / Nationalized bank having net worth not less than ₹ 100 crore.
2. The bidder must have turnover in similar work of ₹ 450,00,000/- (Rupees Four Hundred Fifty Lakhs Only) during last three financial years and should be profit making during the last year.
3. The bidder should have experience one similar work of about ₹ 363,00,000/- (Rupees Three Hundred Sixty Three Lakhs) during any last 5 financial years. The consent/approval/license for providing the services as per the complete scope of work provided in the tender document shall be kept valid for the entire duration of the contract and it shall be the sole responsibility of the contractor to maintain/renew the validity of the such consent/approvals there under from time to time, failing which it may lead to cancellation of contract.
4. The bidder has not been debarred and/or blacklisted by any Central Government / or any State Government Department(s) and the bidder should not have any litigation in any of the labour court(s). An affidavit to that effect on Non-Judicial Stamp paper of ₹ 10/- duly notarized shall be enclosed with the technical bid as per format attached in the tender documents
