1) Scope of Work:

Petronet LNG Limited is interested to award a job contract for Design, Procurement, Fabrication Testing and Supply of Emergency Response Vehicle (ERV) on a BS III BHARAT BENZ 1214 CBC Chassis (model with anti-roll bar and air conditioner), diesel engine type, and incorporating extended crew cabin, LNG transfer pump skid, one DG set, one 500 kg DCP vessel, one DCP monitor, 2 DCP hose reel, nitrogen expellant system, piping, controls and stowage at Petronet LNG Limited, Kochi.

2) Minimum Bid Qualification Criteria:
