### 1. SCOPE OF WORK:

Petronet LNG Limited is interested to award a job contract for Construction of Road on East Side & drains on East & South side of plant (perimeter) at Petonet LNG terminal at Dahej, Gujarat

### 2. MINIMUM BID QUALIFICATION CRITERIA:

Few important and mandatory criteria are mentioned below. The tender document contains complete list of Bid Evaluation Criteria.

a) The bidder shall submit Earnest Money Deposit (EMD) for an amount of Rs.800,000/- (Rupees Eight Lakhs Only) in form of Demand Draft or Bank Guarantee. The Bank Guarantee should be from a Scheduled commercial Bank having Credit Rating of AA+ and above & having net worth not less than Rs. 100 crores.

b) The turnover of the Bidder in similar works shall be minimum Rs. 5 Crore (Rupees Five Crore Only) during preceding 3 to 5 years. The Bidder shall submit Income tax return copies (BL Sheet and P & L statement) supporting turnover requirement. Net worth of the bidder should be positive in preceding financial year.

c) The bidder should have experience of at least one similar work of about Rs. 3 Crore (Rupees Three Crore Only) in previous 5 to 7 years period. Bidder shall enclose details of experience & past performance of works/jobs done of similar nature in support of experience. Copy of Work order or completion certificate shall be attached.

d) The bidder has not been debarred and/or blacklisted by any Central Government / or any State Government Department(s) and the bidder should not have any litigation in any of the labour court(s). An affidavit to that effect on Non-Judicial Stamp paper of Rs. 20/- duly notarized shall be enclosed with the technical bid.
