1) Scope of Work:

Petronet LNG Limited is interested to award a contract for Providing Car Transport Services for a period of 2 Years at Petronet LNG Limited, Kochi.

2) Minimum Bid Qualification Criteria:

Few important and mandatory criteria are mentioned below. The tender document contains complete list of Bid Evaluation Criteria.

1) The bidder should submit Earnest Money Deposit (EMD) for an amount of Rs. 2,88,000.00 (Rupees Two Lakhs and Eighty Eight Thousand Only) in the form of Bank/Demand Draft /Bank Guarantee (as per format attached in the tender documents) in favor of "Petronet LNG Limited, Kochi".

2) The bidder must have a minimum average annual turnover of Rs. 1,10,00,000.00 (Rupees One Crore and Ten Lakhs Only) and should be profit making during the last three years. In this connection bidder are requested to provide copy of the audited balance sheet and profit and loss account for immediate last three financial year ending 31.03.2016.

3) The bidder should have during the last five years for providing similar/relevant Services as on 30.06.2016 at least:

- (a) One contract of value not less than Rs. 110.00 Lakhs or
- (b) Two contracts of value not less than Rs. 70.00 Lakhs each or
- (c) Three contracts of value not less than Rs. 50.00 Lakhs each.

4) Agency/Tenderer should own at least a fleet of 10 commercial vehicles of different makes out of which 5 should be in the name of the Agency / Proprietor (documentary evidence in the form of RC Book, Insurance Policy etc. to be submitted).

5) All the vehicles which are to be provided should be new or having registration after 1st Jan, 2016 and maximum 10,000.00 kilometers travelled.

6) The bidder should not been debarred and/or blacklisted by any Central Government / or any State Government Department(s) and the bidder should not have any litigation in any of the labour court(s).
