## 1. SCOPE OF WORK:

Petronet LNG Limited is interested to award a job contract for Providing Light Commercial Vehicle & Executive Coach Services on round the clock, 12 Hours and 24 Hours hire basis at Petonet LNG terminal at Dahej, Gujarat

## 2. MINIMUM BID QUALIFICATION CRITERIA:

Few important and mandatory criteria are mentioned below. The tender document contains complete list of Bid Evaluation Criteria.

- a) The bidder shall submit Earnest Money Deposit (EMD) for an amount of Rs.432,000/- (Rupees Four Lakhs Thirty Two Thousand Only) in form of Demand Draft or Bank Guarantee. The Bank Guarantee should be from a Scheduled commercial Bank having Credit Rating of AA+ and above & having net worth not less than Rs. 100 crores.
- b) The turnover of the Bidder in similar works shall be minimum Rs. 2.7 Crore (Rupees Two Crore Seventy Lakhs Only) during preceding 3 to 5 years. The Bidder shall submit Income tax return copies (BL Sheet and P & L statement) supporting turnover requirement. Net worth of the bidder should be positive in preceding financial year.
- c) The bidder should have experience of at least one similar work of about Rs. 2 Crore (Rupees Two Crore Only) in previous 5 to 7 years period. Bidder shall enclose details of experience & past performance of works/jobs done of similar nature in support of experience. Copy of Work order or completion certificate shall be attached.
- d) The bidder has not been debarred and/or blacklisted by any Central Government / or any State Government Department(s) and the bidder should not have any litigation in any of the labour court(s). An affidavit to that effect on Non-Judicial Stamp paper of Rs. 20/- duly notarized shall be enclosed with the technical bid.
