#### 1. SCOPE OF WORK:

Petronet LNG Limited is interested to award a job for procurement of fire foam tender at Petonet LNG terminal at Dahej, Gujarat

#### 2. MINIMUM BID QUALIFICATION CRITERIA:

Few important and mandatory criteria are mentioned below. The tender document contains complete list of Bid Evaluation Criteria.

### **Mandatory Requirements**

#### 1. Commercial

- a) The bidder shall submit Earnest Money Deposit (EMD) for an amount of Rs.310,000/- (Rupees Three Lakhs Ten Thousand Only) in form of Demand Draft or Bank Guarantee in favour of Petronet LNG Limited, Dahej. The Bank Guarantee should be from a Scheduled commercial Bank having Credit Rating of AA+ and above & having net worth not less than Rs. 100 crores.
- b) The bidder must have an minimum average annual turnover of Rs. 170 Lakh (Rupees One Hundred Seventy Lakhs Only) during preceding 3 to 5 years. The Bidder shall submit Income tax return copies (BL Sheet and P & L statement) supporting turnover requirement. Net worth of the bidder should be positive in preceding financial year.
- c) The bidder should have following experience in previous 5 to 7 years period:
  - a) one similar contract of value not less than Rs. 130 Lakh or.
  - b) two similar contracts of value not less than Rs. 70 Lakh each or,
  - c) three similar contracts of value not less than Rs. 50 Lakhs each

Bidder shall enclose details of experience & past performance of works/jobs done of similar nature in support of experience. Copy of Work order or completion certificate shall be attached.

d) The bidder has not been debarred and / or blacklisted by any Central Government / or any State Government Department(s) and the bidder should not have any litigation in any of the labour court(s). An affidavit to that effect on Non-Judicial Stamp paper of Rs. 20/- duly notarized shall be enclosed with the technical bid.

### 2. Technical

- a) Bidders should mention make & model of the Pump quoted & enclose detailed technical specifications and OEM's technical literature / leaflets along with the bids. Tenders submitted without such supporting documents will not be considered. Requirement of pump is mentioned in the technical specification. Bidders shall provide the updated authorization certificate of the pump manufacturer for sales & after sales service of the pump. (necessary documentary evidence should be attached)
- b) The Pump offered by the bidder should be CE certified & the certification should be valid for at least one year. The certificate should be submitted with the offer.
- c) Bidders to submit a full set of drawings in load distribution diagram, material of construction, drawings of water tank / foam tank, wiring diagram, pump, PTO arrangement drawings, and any other drawings relevant to the offer. Offers of bidders who fail to submit drawings & technical data shall be rejected.
- d) All testing facilities like tilting test, gradient test, deep lift test, endurance test etc should be available with the manufacturer at their premises, the same should be supported by documentary evidence failing which the offer shall be rejected. Bidders who have done similar tests should provide documentary evidence along with the bid.

## **General Requirements**

- a) The bidder should have minimum 5 years of experience for providing minimum 10 fire tenders in oil & gas industries. (necessary documentary evidence i.e. work orders, completion certificate etc. should be attached)
- b) Bidder should be manufacturer of fire fighting appliances and should have at least 8 years of experience in the field of manufacturing fire fighting vehicles.
- c) The bidder shall provide PO Copy for 5 Fire Tenders fabricated with ISO6063 Aluminum Profiles / SS, Sub frame System for Tank Mountings & Metacone Systems. The manufacturer should provide complete technical details including drawing, design and photographs for the ISO6063 Aluminum Profiles. The manufacturer shall provide complete technical details of the subframe design and metacones. Further the load calculation for selection of metacones shall also be provided by the manufacturer.
- d) The Bidder should be ISO certified & possess valid ISO 9001: 2008 certificate / or any other Quality Management System Approved.
- A satisfactory performance certificate from any clients / user of min. 05 years field run should be enclosed along with technical bid.
