



## GLOBAL NOTIFICATION FOR INVITING PROPOSALS FOR CSD DREDGING AT KOCHI LNG TERMINAL

Petronet LNG Limited (PLL) invites proposals, through International Competitive Bidding (ICB), from experienced and financially sound Dredging Contractors for offering CSD dredging services for a firm period of one(1) year at PLL's Kochi LNG Terminal. Services shall be extendable, at PLL's option, for upto three (3) months on same terms and conditions.

Detailed eligibility criteria along with other key terms and conditions are as follows:

### A) Bidders' Eligibility Criteria

- The Bidder must have experience in supplying and successfully operating one cutter suction dredger with experienced manning for an aggregate period of at least six months in the preceding two year period (as on the date of submission of this proposal). Performance certificate, references and work order/ contract obtained from previous clients to be produced to establish the credibility.
- (a) Average annual turnover during the last consecutive three years audited balance sheet, not earlier than year ending March 2015, shall be more than INR one hundred (100) million or equivalent USD (exchange rate 1 USD = 65 INR).  
(b) Positive net worth in the latest financial year (ending 31<sup>st</sup> March 2017).
- (c) A new company less than 3 years old promoted by parent company in dredging related business may provide financial details of parent company as evidence of 2 (a) above provided parent company has more than 50 percent ownership and provides guarantee that ownership will not be reduced during the currency of dredging contract with PLL.
- The Bidder should not be debarred and/ or blacklisted by any Central Government. or any State Government department(s) in the last five years, commencing from 1<sup>st</sup> July 2012.

### B) Price Bid Evaluation Methodology

The Price Bid quoted by the Bidder shall be evaluated on the basis of lumpsum cost to PLL for providing the dredging Services for twelve months.

Annual cost to PLL for each of the Bidder will be calculated based on the amount quoted by the each of the Bidder towards:

- Mobilization and Demobilization cost
- Daily Charges (based on 16 hours of operations each day)
- Idle Time Charges
- Standby Time Charges

Each of the activity duration considered in the Price Bid evaluation shall be as follows:

- Daily Charges duration- 185 days (based on 16 hours of operations each day)
- Idle Time- 30 days
- Standby Time – 150 days

The Bidder providing the Services at the lowest evaluated cost shall be the Successful Bidder.

Price Bid evaluation does not provide advantage to dredger of superior dredge pump specifications.

### C) Key terms and conditions

Other key terms and conditions will also be broadly in line with the earlier dredging tenders and are as follows:

- Bid documents shall be issued to the interested parties at non refundable, tender fee of Rs 5,000/ (including GST).
- Bid security- INR 20 lac
- Contract term- One year from the service commencement date with an extension option for up to three months.
- Service commencement date- 21<sup>st</sup> October 2017
- Allowable age of CSD- Maximum 15 years. Date of first registry not earlier than 15 years as on date of submission of the bid.
- CSD minimum dredge pump rated capacity-500 cbm/ hr solids in situ.
- Capability to dredge up to 16m from CD (in calm condition).
- Fuel- Contractors account. Payment subject to fuel price adjustment as stipulated in the agreement.
- Bidders to offer CSD's manufactured by one of the following:
  - IHC Beaver
  - Ellicot
  - Damen
  - VOSTA
  - ITALDRAGHE
  - Or equivalent\*

\*Manufacturer other than above may be considered in case the CSD has a proven track record of dredging for minimum six months. The Bidder must provide supporting documents. The age of such CSD should not be more than 10 years as on the date of submission of bid.

- Bidder to submit dredge pump curves in the Bid.
