### 1. SCOPE OF WORK:

Petronet LNG Limited is interested to award a job contract for Painting requirement for trestle area of North Jetty at Petonet LNG terminal at Dahej, Gujarat

### 2. MINIMUM BID QUALIFICATION CRITERIA:

Few important and mandatory criteria are mentioned below. The tender document contains complete list of Bid Evaluation Criteria.

a) The bidder shall submit Earnest Money Deposit (EMD) for an amount of Rs.260,000/- (Rupees Two Lakh Sixty Thousand Only) in form of Demand Draft or Bank Guarantee in favor of Petronet LNG Limited, Dahej.

The Bank Guarantee should be from a Scheduled commercial Bank having Credit Rating of AA+ and above & having net worth not less than Rs. 100 crores.

b) The bidder must have minimum average annual turnover of Rs. 150 Lakh (Rupees One hundred Fifty Lakhs Only) during preceding 3 financial years. The Bidder shall submit Income tax return copies (BL Sheet and P & L statement) supporting turnover requirement. Net worth of the bidder should be positive in preceding financial year.

c) The bidder should have during the last 5 years for providing similar/relevant services as on 31.03.2017:-

- one similar contract of value not less than Rs. 120 Lakh or,
- two similar contracts of value not less than Rs. 70 Lakh each or,
- three similar contracts of value not less than Rs. 50 Lakhs each

Bidder shall enclose details of experience & past performance of works/jobs done of similar nature in support of experience. Copy of Work order or completion certificate shall be attached.

d) The bidder has not been debarred and/or blacklisted by any Central Government / or any State Government Department(s) and the bidder should not have any litigation in any of the labour court(s). An affidavit to that effect on Non-Judicial Stamp paper of Rs. 20/- duly notarized shall be enclosed with the technical bid. The format of the affidavit is attached with the tender as Appendix A.

e) The bidder shall submit Balance Sheet, Profit & Loss Account & ITR copies for last 3 financial years.
