



NOTICE INVITING TENDER (NIT) FOR SELECTION OF CONTRACTOR FOR PROVIDING SECURITY SERVICES AT PETRONET LNG LIMITED, DAHEJ (GUJARAT) INDIA

Petronet LNG Limited, a company promoted by Bharat Petroleum Corporation Limited ("BPCL"), GAIL (India) Limited ("GAIL"), Indian Oil Corporation Limited ("IOC") and Oil & Natural Gas Corporation Limited ("ONGC"), is engaged in the business of import, storage, regasification and marketing of Liquefied Natural Gas in India. The company invites bids from the prospective bidders for providing Security Services at PLL's Dahej LNG Terminal at Gujarat (India). Bids to be submitted in accordance with the Tender Document reference no. **PLL/DHJ/SC/7083/2018**.

The Bidder should meet the techno-commercial Bid Evaluation Criteria (BEC) as stated below and any Bidder not meeting the same will be rejected.

Bid Evaluation Criteria (BEC)

Commercial

- The Bidder shall submit Earnest Money Deposit (EMD) for an amount of INR 20,00,000/- (Indian Rupees Twenty Lakh only) in the form of Demand Draft or Bank Guarantee in favor of Petronet LNG Ltd. The Bank Guarantee should be from a scheduled / Nationalized bank.
- The average annual turnover of the Bidder in similar works shall be minimum INR 7,00,00,000/- (Indian Rupees Seven Crore only) during the financial year 2014-15, 2015-16 and 2016-17. The Bidder shall submit balance sheet, profit and loss account and Income Tax Return copies for last three financial year duly certified by statutory auditor of the company.
- Net worth of the Bidder should be positive during preceding financial year.
- The Bidder should have following experience during last five years, the last 5 (five) years shall be counted from the last day of bid submission date.
 - One (01) similar contract of value not less than INR 11 Crore; or,
 - Two (02) similar contracts of value not less than INR 6 Crore each; or,
 - Three (03) similar contracts of value not less than INR 4 Crore each.

The Bidder shall submit work /service order copy(ies) and their completion certificate(s) in support of the above.

Technical

- The Bidder should be registered under the Private Security Agencies Regulation Act -2005, of Govt. of Gujarat or concerned act of the governing state and rules made thereunder and amendments thereto.
- The Bidder should have employed more than one thousand (1000) security personnel and should have deployed at least five hundred (500) Ex-servicemen from either Army or Navy or Air Force or para military forces during the year 2016-17. The Bidder should furnish copy(ies) of work orders in support of the same. Supporting documents confirming to the technical requirement to be attached.
