**(CHARGES SCHEDULE)**

Fully-inclusive Charges (Inclusive of all Direct Tax and Indirect Tax except Goods and Service Tax) for the performance of the Services are as follows:

	Description	Price (in Rs.)*
1.	Lumpsum Mobilization Cost.	
2.	Daily Charges with fuel on Contractors' account (based on 16 hours of CSD operation & other associated dredging activities).	
3.	Daily Idle Time Charge with all fuel on Contractors' account.	
4.	Daily Standby Time charges with all fuel on Contractors' account.	
5.	Lumpsum Demobilization Cost.	
6.	Diesel Oil Price	(DO Price for Trivandrum obtained from IOCL website applicable as on <b>28th April 2018</b> , to be inserted)

Note:

1. The above Charges quoted by the Contractor is inclusive of cost of all fuel, lubricants, direct taxes and all other costs and expenses in relation to the Services and excludes Goods and Service Tax. Goods and Service Tax, if applicable shall be paid additionally by PLL. Income tax deduction as per statutory norms shall be effected while releasing the payment for the invoices and the same shall be deposited to tax authorities. The price quoted above shall be a firm price for the entire Term including the extension period, if any, except any fuel price adjustment for variation in fuel price as per Exhibit D. All cost, including cost of fuel for the associated dredging equipments used for leveling, transportation etc. shall be included in the above charges.
2. Quotations to be based on '**Operating Time**' of 16.0 hours. This 'Operation Time' of 16.0 hours per day shall be exclusive of shifting of Cutter Suction Dredger, relocation of pipelines, clearing of obstruction in cutter etc.
3. On shore jobs such as formation of bund/dykes, transportation of dredge material to west side of PLL plot (2 Kms), maintenance of dyke & outlet point etc. are included in above quote.
