Sunak, who lost the last Conservative leadership race in a run-off against Liz Truss, has gained the most public support of Members of Parliament to replace her as Tory leader...

Sunak is of Indian descent and is married to Akshata Murthy, the daughter of Infosys founder NR Narayana Murthy.

Sunak has the backing of 60 MPs, compared with 16 MPs for Mordaunt. His lead, however, is slimmer against the wildcard Johnson, who was ousted from the premiership in July and left office September 6.

While Sunak and Johnson are yet to officially declare their candidacy, experts have picked the former as the front-runner and some bookmakers have included as an accused in the case, the officer said.

the Conservatives by bringing the best talent into government to deliver for the British people, tweeted former Cabinet minister Dominic Raab...

Announcing her candidacy, Mordaunt said she was united for a fresh start, a new party and leadership in the national interest.

The governing Conservative Party has ordered a lightning-fast race that aims to have a new PM in place within a week at a time when Britain can ill afford uncertainty at the top.

Defence secretary Wallace said: "At the moment, I'm leaning towards Boris Johnson." He noted that Johnson was the only candidate with the UK-wide electoral legitimacy, having won a thumping victory for the Tories over Labour in 2019.

Some other Tories, however, were agnostic at the prospect of Johnson's comeback. Veteran backbencher in Roger Gale warned that Johnson could face a wave of resignations from MPs refusing to serve under him as leader.

Crispin Blunt MP told the BBC that Johnson was a "fantastic communicator" but Sunak was "a much more serious personality" who could impart a serious message to the country.

"Buck Rishi Sunak to be our next PM. He has the plan and the credibility to restore financial stability, help get inflation down and deliver sustainable tax cuts over time; and unite

Tory MPs will be able to run, as the party has set a threshold of 100 MPs for candidates to even get on the ballot paper, and there are a total of 357 MPs in the party, Sunak is now more than halfway towards that threshold.

Lawmakers will vote to knock out one of the three candidates, and will hold an indicative vote on the ballot paper, and the party's 172,000 members will then get to decide between the two finalists in an online vote.

The new leader is due to be selected by October 28. Nominations for a new leader will close on Monday afternoon.

The new government debt rose to the highest level in almost 60 years last month and retail sales slumped, underscoring the scale of the economic challenges facing whoever replaces Truss after her administration imploded under the weight of its failed financial plan.
