Five microbreweries in city, two more soon

THE EXCISE Department has allowed the setting up of microbreweries and the sale of draught beer in the national capital.

Officials said around seven entities applied for microbrewery licences, and five have been approved and active.

"There were provisions for microbreweries and draught beer under the now-scrapped Delhi Excise Policy 2021-22 but they were not implemented as the revised terms and conditions under the new policy were not notified on time. However, under the old regime, we have approved terms and conditions and are allowing microbreweries to set up in Delhi," said an official.

The official added that the department has conducted inspections at more places and is waiting for clearance from the Delhi Pollution Control Committee (DPCC). Once the work is completed, the two en-

tities will also get the approval soon, said an official.

According to a list from the department, Effingut in Saket, Evergreen in Janpath, Ministry of Beer in Connaught Place, Royal Brewer at Hotel Royal Plaza, and Fort City Brewery in Hauz Khas Market are functional.

The two companies which have also applied for licences are Route 4 in Ambience Mall in Vasant Kunj and Flow Brew and Dine at DLF Avenue Mall in Saket.

"People, especially youths, prefer fresh beer over artificial, canned or bottled beer. Fresh beer is also in high demand, so, it will create revenue and people will have options," said the official.

With the new terms and conditions, more companies, restaurants, and hotels with licences L-16, L-17, L-18 and L-19 can apply for establishing microbreweries. The interested owners will have to apply for the L-11 licence for retail vends of beer manufacturing by microbrewery.

As per the conditions, a microbrewery may be set up where draught beer is manufactured and served to customers for consumption on the premises with an installed capacity of not more than 500 litres per day, subject to clearance by the DPCC on pollution control and submission of a project report. However, the price of such beer is not decided by the excise department.

The licensees fix the price for the brewery beers, said the official.

Delhi riots: HC grants bail to Tahir Hussain in five cases

THE DELHI High Court Wednesday granted bail to former AAP councillor Tahir Hussain in five cases relating to the 2020 Northeast Delhi riots.

A single judge bench of justice Anish Dayal said, "Bail granted subject to conditions..." Among sections of IPC, Hussain had been booked for rioting, mischief by fire and criminal conspiracy.

Appearing for Hussain, senior advocate Salman Khurshid had argued that in initial witness statements, his client had not been named but his name featured in subsequent ones. Khurshid had argued that no specific act has been attributed to Hussain. He had argued that all co-accused had been granted bail. There are 11 cases against Hussain, who has been booked in 'larger conspiracy' case under UAPA relating to the riots.

Vehicles & staff stranded, cargo damaged: Rains spell double whammy for goods transporters

THEIR VEHICLES and staff stranded in at least one north Indian state coupled with their lack of confidence in the successful transportation of goods to the national capital – the city's truckers and transporters find themselves stuck in a vicious circle as they stare at financial distress.

The safety of employees and vehicles, the damage that incessant rain can cause to cargo and expenses ranging from salaries, maintenance and EMLs are among the worries of Delhi's average goods carrier business owners that have continued to compound with rain lashing the city since the weekend.

"One of my vehicles which started from Ludhiana the day before yesterday and would have normally reached Delhi after an overnight journey is still stranded in Punjab. Transporters from other states are declining to transport goods to the waterlogged capital and its surrounding regions or making bookings from Delhi," said Rajender Kapoor, president,

During 2021-22, Delhi had over 2.45 lakh vehicles registered as goods carriers and tractors engaged in cargo transportation operations according to the Delhi Statistical Handbook.

According to those who are part of the industry, while not all consignments carried to the city are meant for it, Delhi serves as hub for shipments which are further relayed not only to Haryana and Uttar Pradesh but across the country.

"Business has been going

down every day since the weekend; we are just not getting any bookings. If things continue like this, how will we be able to pay salaries of our staff or the EMLs of our vehicles?" asked Kirti Nagarkar-based transporter Arun Sharma.

The daily floating population of vehicles of various makes and sizes engaged in the trucking trade in the NCR, according to transporters, is an estimate 80,000 to 90,000. But the conditions prevailing in Delhi in the last few days due to rain – also in parts of Punjab, Haryana, Himachal Pradesh and Uttarakhand – had translated into an impact on north India's connection to the national supply chain.

"If the situation does not change for the better, the inventories and stocks currently being held by businesses – which have already been diminished over the past days – will begin running out. This will be followed by a sudden upsurge in demand which will take many more days to fall in sync and finally allow the stabilisation of the industry," said Bal Malik Singh Chairman, from the core committee of the All India Motor Transport Congress.

Chopped body found near Geeta colony flyover; search on

New Delhi: The Delhi Police Wednesday said they found chopped-up remains of a person in two places near Geeta Colony flyover.

DCP (North) Sagar Singh Kalsi said, "Prima facie it seems like a body of around a 35- to 40-year-old person." A senior police offi-

cer said that drones were used to scan for any evidence. "...CCTVs at a distance are being scanned... it is being prima facie assumed that the body is of a woman and we have launched a search on missing persons," the officer said. A murder case has been lodged at Kotwali police station. **ENS**

Man booked for abusing, misbehaving in Air India flight

THE DELHI Police booked a man for allegedly abusing flight crew members, smoking and breaking lavatory door on an Air India flight from Toronto to Delhi.

Police said he allegedly changed his seat and hurled abuses at staffers. "He started abusing the economy class crew. So, we informed PIC and gave him an oral warning, but after lunch services, we got the LAV (lavatory) smoke alarm... he (was) caught with a cigarette lighter... he pushed me back... ran to his seat... and I tried to stop him... he again pushed and abused me... He broke LAV door,"

read the FIR lodged on complaint of a crew member.

A statement by the airlines said, "A passenger on flight AI188 ... displayed unacceptable aggression... He smoked in lavatory, damaged lavatory door and assaulted crew and passengers, leaving them with minor injuries."

"We tried to restrain him as per SOP but were not able to control him... We got ten passengers and two crew who... restrained him... he (accused) tried to beat a passenger," read the FIR. On arrival, he was handed over to security, and the matter has been reported to Directorate General of Civil Aviation, said an official.

A case was registered at IGI Airport police station.

Rahul Gandhi's search for new home may end at Sheila Dikshit's Nizamuddin residence

FORMER CONGRESS President Rahul Gandhi may have serendipitously found a new home – former Delhi Chief Minister and late Congress stalwart Sheila Dikshit's Nizamuddin (east) residence.

"One of the many locations" that the ex-Wayanad MP is understood to have looked at in the city, according to party sources, the 3-BHK property is apparently among his top preferences following leads by some "common contacts".

According to insiders, the current occupants of the property, the three-time CM's ex-MP son Sandeep Dikshit and his family, are planning to move out and had put out information to this effect which came to the notice of

Rahul's office leading to an inquiry. Sources said since he had visited the house "several times" earlier as well, Rahul was likely to take it up on rent as Sandeep moves to another property in the neighborhood.

Rahul was convicted in a defamation case by a Surat court

and awarded a two-year sentence leading to his disqualification from the Parliament. This triggered a notice from the Lok Sabha asking him to vacate the 12, Tughlaq Lane residence allotted to him.

Staying with his mother Sonia Gandhi at her 10, Janpath home since, Rahul, according to sources, was understood to be in favour of moving into the Nizamuddin property which he has "visited several times" to call on the late Delhi CM when she was alive.

On July 8, Gujarat High Court

had declined to stay Rahul's conviction in the criminal defamation case, making several observations including that "the offence committed by the accused falls in the category of moral turpitude" and that the "need of the hour" is to "have purity in politics".

Gandhi was found guilty of criminal defamation in a complaint filed by Surat West BJP MLA Purnesh Modi who objected to his remarks in Kolar, in the run-up to the Lok Sabha elections in April 2019, about "thieves with the Modi surname".
